- **10.** In accordance with the <u>Companies Act 1992</u>, there is no minimum share capital required for a Bahamas representative office company;
- 11. In accordance with <u>Bahamas Fiscal Code</u>, VAT registration is compulsory for companies with Bahamas derived annual turnover exceeding US\$100,000; Bahamas Corporations with no local sourced income do not need to file income tax or VAT returns. If required Healy Consultants Group PLC will be happy to register your Bahamas company for income tax and VAT for a one-time fee of US\$950;
- 12. If our Client and Healy Consultants Group PLC properly plan this engagement, our Clients will <u>not</u> have to travel during this engagement. Healy Consultants Group PLC will efficiently complete representative office registration and corporate bank account opening in a timely manner without our Client's presence. Instead, our Client will need to i) sign and get documents legalized in the embassy in their country of origin; and ii) courier the originals to Healy Consultants Group PLC's office;
