1. Healy Consultants' fees to legally register our Clients' Marshall Islands Company within [one week \(click link\)](#) by **i)** choosing the optimum regulatory license for our Client's business activities; **ii)** reserving a company name with [Registrar of Corporations](#); **iii)** settling our accountant and lawyer fees and **iv)** preparing a high quality company incorporation application for [Registrar of Corporations](#);

In accordance with the [Marshall Islands Companies Act \(click link\)](#), a Company shall as from the date of its incorporation have a legal registered office in Marshall Islands, to which all official Government communications and notices may be addressed. To comply with this statutory requirement, Healy Consultants' Marshall Islands office will be the registered office address for your company. Thereafter, this address will be used to receive government correspondence including **i)** tax letters **ii)** notice of the legal annual return; and **iii)** all government communications. Most of our Clients wish to place [Healy Consultants' Hong Kong or China office address](#) on invoices, contracts, websites and business cards;

3. This fee is an estimate of Government costs payable during your Firm's engagement. All Government fee payments will be supported by original receipts and invoices. Examples of Government costs include **i)** reserving the company name **ii)** register the company with the [Registrar of Corporations](#) and **iii)** obtain the employer identification number at the [Marshall Islands Social Security Administration](#). Following engagement completion, Healy Consultants will refund our Client any excess of funds received over actual Government costs paid;
4. Healy Consultants will be pleased to open [an international corporate bank account](#) (click link) without our Client travelling. Examples include New York, Germany, Liechtenstein, Austria, Bulgaria, South Africa, Australia, London, South America or Dubai. Our fee to be both nominee director and shareholder amounts to US\$6,600 per annum. Being the sole shareholders and sole director of a Client's company exposes Healy Consultants to reputation, litigation and financial risk;

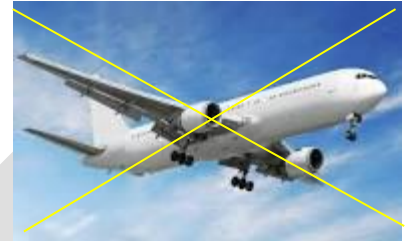

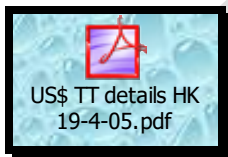
