### Notes to invoice above

1. These costs include **a)** annual Taiwan government registration fees **b)** registered office for 12 months and **c)** company secretary fees for 12 months. In accordance with Taiwan's Company Act, a Taiwanese limited company is required to have a registered office at which all statutory records and other corporate documents must be kept available for review. Healy Consultants' Taiwan business office will be the registered office address for your Taiwan company. Thereafter, this address will be used to receive government correspondence including **a)** notice of changes in Taiwanese company law **b)** notice of liquidation of company **d)** notification of annual business license fees overdue. Please note, the Taiwan company registered office address shall **not** be printed on our clients' sales invoices, business cards or business websites, without the written consent of Healy Consultants. Our Clients' requirement to have a Taiwanese business address is a separate service explained in more detail under Virtual Office services in **section 3.** below.

Healy Consultants will also act as your resident Taiwan company secretary, and our annual responsibilities include:

- a.** Drafting resolutions and preparing minutes of the board of directors and shareholders;
  - b.** Effecting changes in the board of directors and shareholders;
  - c.** Making amendments to the company's constitutive documents;
  - d.** Maintaining the company's statutory records;
  - e.** Preparing and lodging annual forms and tax returns with the Taiwan Tax Bureau;
  - f.** Submitting audited financial statements to the Ministry of Economic Affairs and Tax Bureau.
2. Healy Consultants will open corporate bank account without you having to visit the bank. Your corporate bank account will be with one of the top five international retail banks and will include credit card, ATM card, internet banking and cheque book;
3. Most of our Clients wish to place Healy Consultants Taiwan Office address on invoices, contracts, websites and business cards. Healy Consultants annual fee amounts to US\$1,100. Refer to attached Adobe file to view a draft virtual office agreement:
