 Healy Consultants Group fees to efficiently and effectively complete Kenya branch office registration within <u>eight weeks</u> by i) choosing the optimum regulatory license for our Client's business activities ii) reserving a branch office name with <u>Huduma Centre</u> iii) settling our accountant and lawyer fees and iv) preparing a high quality branch office incorporation application for <u>Registrar of Companies at the Attorney</u> <u>General's Chambers</u>;

All <u>engagement fees</u> (click link) are agreed and paid up front and agree to the fees published on our country web pages. Consequently, there are no hidden fees, surprises or ambushes throughout the engagement. To comply with this statutory requirement, Healy Consultants Group Kenya office will be the registered office address for your branch. Thereafter, this address will be used to receive government correspondence including i) tax letters ii) notice of the legal annual return; and iii) all government communications. Most of our Clients wish to place <u>Healy Consultants Group office address</u> on invoices, contracts, websites and business cards;
- 3. This fee is an estimate of government costs payable during your Firm's engagement. For transparency purposes, all government fee payments will be supported by original receipts and invoices. Examples of government costs include i) reserving the branch name with the <u>Business Licensing Agency</u> (BLA); ii) preparation of branch deeds and articles of association; iii) paying the stamp duty fee to <u>Kenya Revenue Authority</u> and iv) signing of the declaration of compliance at the <u>Commissioner for Oaths</u>. Following engagement completion, Healy Consultants Group will refund our Client any excess of funds received over actual Government costs paid;

All banks will be top tier banks in these countries with excellent internet banking services. Example of our global banking partners include HSBC, Standard Chartered Bank, Citibank, Barclays, Standard bank, ANZ bank, VTB bank, UBS, Credit Suisse;



The banks enjoy ultimate power of approval of corporate bank account applications. Consequently, guaranteed success is outside of Healy Consultants Group control. What is inside our control is the preparation and submission of a high-quality bank application that maximizes the likelihood of approval. To date, we enjoy a 100% approval record because of our global banking relationships and determination.

Global banks continue to tighten corporate bank account opening procedures, their internal compliance departments completing more thorough due diligence of Clients. Consequently, our Clients should expect the bank account approval period to take up to 4 weeks. Furthermore, global banks now require evidence of proof of business in the country where the corporate bank account will be, including sales contracts or lease agreement;

- 5. In accordance with Kenya <u>Tax Act Chapter 470</u>, each entity must register for corporate tax and VAT at the <u>Kenya Revenue Authority</u> (KRA);
- 6. For an active trading branch office, these <u>accounting and tax</u> fees are an estimate of Healy Consultants Group fees to efficiently and effectively discharge your annual branch accounting, auditing and tax obligations. Following receipt of a set of draft accounting numbers from your branch office, Healy Consultants Group will more accurately advise accounting and tax fees. For a dormant branch office, HealyConsultants Group fees are only US\$950;
- 7. All fees quoted in this invoice correspond to fees quoted <u>on Healy Consultants Group Pwebsite</u>. Please review this invoice carefully to identify errors. Healy Consultants Group will efficiently and effectively and aggressively complete branch registration and corporate bank account opening in a timely manner without our Client presence. - 13. Branch business activities are limited to the activities of its head office. The branch suffers standard corporate income tax of 37.5%. A branch can i) lease office premises ii) issue sales invoice to Clients and iii) sign local legal contracts. A branch can import and export goods;

- 15. Depending on our Client's business and nationality, the Kenya Government may require a special regulatory license to carry on your business in the country. Healy Consultants Group will assist our Client secure license approval; there may be additional engagement fees. However, the Government enjoys ultimate power of approval of branch registrations and business licenses;
- 16. If required, Healy Consultants Group will be pleased to assist your firm to secure employee visa approvals. Our fee is US\$4,950 for the first employee, US\$3,950 for the second employee, US\$2,950 per employee thereafter. Our employee visa fees include preparation of a quality visa application and submitting to the correct Government immigration officers.
