Most of our Clients wish to place [Healy Consultants Group PLC' office address](#) on invoices, contracts, websites and business cards;
3. This fee is an estimate of government costs payable during your Firm's engagement. For transparency purposes, all government fee payments will be supported by original receipts and invoices. Examples of government costs include: **i)** filing the incorporation documents with the Registrar of Companies at [Companies House](#) and **ii)** the Companies House fee for filing the annual return in subsequent years. While Healy Consultants Group PLC has made every effort to ensure the accuracy of these fees, any excess will be borne by our Client. Following engagement completion, Healy Consultants Group PLC will refund our Client any excess of funds received over actual Government costs paid;

5. In accordance with UK [Value Added Tax Law 1994](#), each entity expecting revenue in excess of £81,000 must register for VAT with Revenue and Customs Authority ([HMRC](#));
6. For an active trading limited partnership, these [accounting and tax](#) fees are an estimate of Healy Consultants Group PLC' fees to efficiently and effectively discharge your annual company accounting and tax obligations. Following receipt of a set of draft accounting numbers from your company, Healy Consultants Group PLC will more accurately advise accounting and tax fees. For a dormant partnership, Healy Consultants Group PLC fees are only £950;
7. All fees quoted in this invoice correspond to fees quoted [on Healy Consultants Group PLC's website](#). Please review this invoice carefully to identify errors. 11. From the 24<sup>th</sup> of July, 2017, all Scottish Limited Partnerships (LPs) must register corporate particulars of their PSC (Persons with Significant Control) with the [UK Companies House](#);

13. Depending on our Client's business and nationality, the British Government may require a special regulatory license to carry on your business in the country.
