Thereafter, this address will be used to receive government correspondence including **i)** tax letters; **ii)** notice of the legal annual return and **iii)** all government communications. Most of our Clients wish to place [Healy Consultants Group PLC's office address](#) on invoices, contracts, websites and business cards;
3. This fee is an estimate of government costs payable during your Firm's engagement. For transparency purposes, all government fee payments will be supported by original receipts and invoices. Examples of government costs include **i)** reserving the company name with the [Register of Enterprises](#); **ii)** preparation of company deeds and articles of association; **iii)** notarization all company documents; **iv)** registering at the Commercial Registry and **v)** registering with other relevant state departments. 4. In accordance with the Latvia [VAT Law](#), it is compulsory for companies that deal with commerce or services that are subject to VAT in Latvia to register for VAT, if their annual sales exceed €50,000;

It is a time consuming task, and Healy Consultants Group PLC will shelter our Client from the associated administrative challenges. As you can appreciate, it is a difficult task to obtain bank account approval through a newly formed company when shareholders, directors and bank signatories reside overseas. Healy Consultants Group PLC will prepare a business plan for the bank to optimize the probability of corporate bank account approval. 

What is inside our control is the preparation and submission of a high quality immigration visa application that maximizes the likelihood of visa approval;
