In accordance with the <u>Swedish Companies Act 2005</u>, a Sweden representative office shall as from the date of its registration have a legal registered office in Sweden, to which all official Government communications and notices may be addressed. To comply with this statutory requirement, Healy Consultants Group PLC' Sweden office will be the registered office address for your representative office. Thereafter, this address will be used to receive Government correspondence including i) tax letters ii) notice of the legal annual return; and iii) all government communications. Most of our Clients wish to place Healy Consultants Group PLC <u>Sweden office address</u> (click link) on invoices, contracts, websites and business cards;

- 3. In accordance with the Swedish law, each entity must register for VAT at the <u>Swedish Tax</u> <u>Agency</u>;
- 4. This fee is an estimate of government costs payable during your Firm's engagement. For transparency purposes, all government fee payments will be supported with original receipts and invoices. This fee includes i) representative office name reservation and ii) representative office registration fee at the <u>Swedish Companies Registration Office</u>. Following engagement completion, Healy Consultants Group PLC will refund our Client any excess of funds received over actual Government costs paid;
- 5. Healy Consultants Group PLC will be pleased to open a Swedish corporate bank account without travel. It is a time consuming task, Healy Consultants Group PLC will shelter our Client from the administrative challenges. As you can appreciate, it is a difficult task to obtain bank account approval through a newly formed representative office, when shareholders and directors and bank signatories reside overseas. Healy Consultants Group PLC will prepare a business plan for the bank to optimize the probability of corporate bank account approval. Depending on our Client business and nationality, there is a 20% probability the banks will request a bank signatory to travel for a one hour bank interview. In accordance with <u>Section 9 of the Swedish Companies Act 2005</u>, each Swedish representative office shall have a managing director who is ordinarily resident in Sweden or the European Economic Area (EEA). Exceptions from these requirements may be granted by the Swedish Companies Registration Office. Most of our Clients request Healy Consultants Group PLC to be the <u>resident director</u>. Healy Consultants Group PLC resident director service fee amounts to €6,600 per annum;

- 11. Representative office are not distinguished from branches in Sweden, which means that they can conduct commercial activities, but such activities are, like for a branch, are limited to that of the parent company. The representative office suffers a corporation tax of 22%. A representative office can i) lease office premises and ii) issue sales invoice to Clients and iii) sign local legal contracts. A representative office can import and export goods. The life of the representative office is limited to that of the parent company;
- 12. Some of our Clients engage Healy Consultants Group PLC to <u>recruit (click link)</u> local employees. We have a lot of experience in this area and we are quite skilled at securing quality candidates for our Clients;
- 13. In accordance with the rules of the <u>Swedish Companies Registration Office</u>, the issued share capital of at least €5,500 must be deposited to the corporate bank account during representative office registration. To optimize engagement efficiency and minimize delays, Healy Consultants Group PLC is happy to deposit these fund on behalf of our Clients;
- 14. It is important our Clients are aware of their personal and corporate tax obligations in their country of residence and domicile; and they will fulfill those obligations annually. Let us know if you need Healy Consultants Group PLC help to clarify your local and international annual tax reporting obligations;
- 15. If our Client and Healy Consultants Group PLC properly plan this engagement, our Clients' will <u>not</u> have to travel during this engagement.
