Thereafter, this address will be used to receive government correspondence including **i)** tax letters **ii)** notice of the legal annual return; and **iii)** all government communications. Most of our Clients wish to place [Healy Consultants Group PLCs' office address](#) on invoices, contracts, websites and business cards;

In accordance with the Kenyan [Companies Act Chapter 486](#), each Kenya PLC company must appoint a company secretary, who may be a natural person or a body corporate, but the company secretary must be resident in Kenya. Healy Consultants Group PLCs will act as your Kenya Company Secretary, for which our annual responsibilities include **i)** preparation and filing of the annual return; **ii)** securely maintaining company records; **iii)** liaising with the Kenya Government on behalf of our Client; **iv)** legal filing of changes of company structure; and **v)** ensuring company record compliance with local company law;

3. This fee is an estimate of government costs payable during your Firm's engagement. For transparency purposes, all government fee payments will be supported by original receipts and invoices. Examples of government costs include **i)** reserving the company name with the [Business Licensing Agency](#) (BLA); **ii)** preparation of company deeds and articles of association; **iii)** paying the stamp duty fee to [Kenya Revenue Authority](#) and **iv)** signing of the declaration of compliance at the [Commissioner for Oaths](#). For an active trading company, these [accounting and tax](#) fees are an estimate of Healy Consultants Group PLCs' fees to efficiently and effectively discharge your annual company accounting, auditing and tax obligations. Following receipt of a set of draft accounting numbers from your company, Healy Consultants Group PLCs will more accurately advise accounting and tax fees. 11. In accordance with Kenyan [Companies Act Chapter 486](#), there is no paid-in minimum capital requirement at incorporation. However, the authorized minimum capital for a PLC is US\$67,500 (KES 6,750,000);
12. If our Client and Healy Consultants Group PLCs properly plan this engagement, our Clients' will **not** have to travel during this engagement. Healy Consultants Group PLCs will efficiently and effectively and aggressively complete company registration and corporate bank account opening in a timely manner without our Client presence.
