1. Healy Consultants fees to efficiently and effectively complete Madagascar company registration within [two weeks](#) by **i)** choosing the optimum regulatory license for our Client's business activities **ii)** reserving a company name with [EDM Madagascar](#); **iii)** settling our accountant and lawyer fees and **iv)** preparing a high quality company incorporation application for [EDM Madagascar](#);

All [engagement fees](#) (click link) are agreed and paid up front and agree to the fees published on our country web pages. Consequently, there are no hidden fees or surprises or ambushes throughout the engagement. All engagement deadlines are agreed up front in the form of [a detailed project plan](#), mapping out deliverables by week throughout the engagement term.



Every second day during the engagement, we email our Client a [detailed email engagement status update](#). Our Client is immediately informed of engagement problems together with solutions. In accordance with Madagascar's [Investment Law N 2007-036](#), each LLC shall as from the date of its incorporation have a legal registered office in Madagascar, to which all official Government communications and notices may be addressed. To comply with this statutory requirement, Healy Consultants' Madagascar office will be the registered office address for your company. Thereafter, this address will be used to receive government correspondence including **i)** tax letters **ii)** notice of the legal annual return; and **iii)** all government communications. Most of our Clients wish to place [Healy Consultants' office address](#) on invoices, contracts, websites and business cards;
3. This fee is an estimate of government costs payable during your Firm's engagement. For transparency purposes, all government fee payments will be supported by original receipts and invoices. Examples of government costs include **i)** payment of the state fee for obtaining fiscal identification number at the [Tax Register](#); **ii)** applying for statistical identification number with [EDM Madagascar](#); **iii)** applying for business license (carte professionnelle) at the [EDM Madagascar](#) and **iv)** payment of the fees for publication in the local Gazette. Following engagement completion, Healy Consultants will refund our Client any excess of funds received over actual Government costs paid;

The banks enjoys ultimate power of approval of corporate bank account applications. Consequently, guaranteed success is outside of Healy Consultants' control. What is inside our control is the preparation and submission of a high quality bank application that maximizes the likelihood of approval. 5. In accordance with Madagascar Tax Laws, each entity must register for corporate tax and VAT at the Madagascar [Tax Administration Authority](#) if the annual turnover of taxable goods exceeds US\$60,000;
6. For an active trading company, these [accounting and tax](#) fees are an estimate of Healy Consultants fees to efficiently and effectively discharge your annual company accounting and tax obligations. Following receipt of a set of draft accounting numbers from your company, Healy Consultants will more accurately advise accounting and tax fees. For a dormant company, Healy Consultants fees are only US\$950;
7. All fees quoted in this invoice correspond to fees quoted [on Healy Consultants' website](#). Please review this invoice carefully to identify errors. During the rush of the business day, it is possible that Healy Consultants inadvertently made fee calculation errors, typing errors or omitted services or omitted historic fee payments from Clients. 11. In accordance with Madagascar's [Investment Law N 2007-036](#), there is no minimum issued share capital required for a resident LLC company;





14. If our Client requires nominee shareholder and director [services \(click link\)](#), Healy Consultants will be pleased to assist. Our fee for professional, passive nominee corporate shareholder amounts to US\$2,100 per annum. Our fee to be both nominee director and shareholder amounts to US\$6,600 per annum. Being the sole shareholders and sole director of a Client's company exposes Healy Consultants to reputation, litigation and financial risk;

16. Monthly, quarterly and mid-year Government tax obligations include monthly and quarterly payroll reporting, VAT and corporation tax return filing. 17. It is compulsory for every Madagascar company to appoint a legal representative, who is ordinarily resident of Madagascar. To minimize complexity, Healy Consultants recommends our Client appoint their own Madagascar staff members already in Madagascar. If our Client is uncomfortable with this strategy, Healy Consultants will provide nominee legal representative. Our annual fee for the same is US\$4,800 per nominee;
18. It is important our Clients are aware of their personal and corporate tax obligations in their country of residence and domicile. Let us know if you need Healy Consultants help to clarify your local and international annual tax reporting obligations;
19. During the engagement, shareholders and directors' documents may need to be translated into the local language before the Government and Bank approves company registration and corporate bank account opening respectively. Consequently, our Client should budget for possible additional translation and embassy attestation fees. Either our Client or Healy Consultants can complete this administrative task;
- As always, Healy Consultants will negotiate with all third parties to eliminate or reduce additional engagement costs. For transparency purposes, all third party fee payments will be supported by original receipts and invoices.
