In accordance with the Marshall Islands Companies Act (click link), a Company shall as from the date of its incorporation have a legal registered office in Marshall Islands, to which all official Government communications and notices may be addressed. To comply with this statutory requirement, Healy Consultants' Marshall Islands office will be the registered office address for your company. Thereafter, this address will be used to receive government correspondence including i) tax letters ii) notice of the legal annual return; and iii) all government communications. Most of our Clients wish to place Healy Consultants' Hong Kong or China office address on invoices, contracts, websites and business cards:

- 3. This fee is an estimate of Government costs payable during your Firm's engagement. All Government fee payments will be supported by original receipts and invoices. Examples of Government costs include i) reserving the company name ii) register the company with the Registrar of Corporations and iii) obtain the employer identification number at the Marshall Islands Social Security Administration. Following engagement completion, Healy Consultants will refund our Client any excess of funds received over actual Government costs paid;
