1. Healy Consultants fees to efficiently and effectively complete Kuwait CJSC company registration within [6 months](#) by **i)** choosing the optimum regulatory license for our Client's business activities **ii)** reserving a company name with [Ministry of Commerce and Industry](#) **iii)** settling our accountant and lawyer fees and **iv)** preparing a high quality company incorporation application for [Ministry of Commerce and Industry](#);

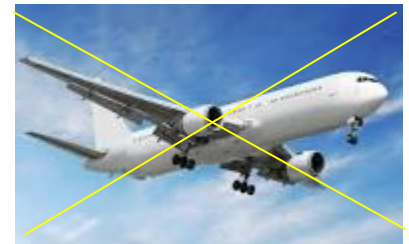

This amount depends on the specific business activity your Firm will carry out in Kuwait. To optimize engagement efficiency and minimize delays, Healy Consultants is happy to deposit these funds on behalf of our clients;
12. In accordance with [Article 191 of the Companies Law](#), the share of the Kuwaiti citizen in a CJSC must be at least 51%. Most of our Clients request Healy Consultants to be the resident shareholder. Healy Consultants resident shareholder service fee amounts to US\$50,500 per annum, as published on our [business website](#);
13. Before company incorporation is complete, the Kuwaiti Government must review and approve a lease agreement for office premises. If your Firm requires this service from Healy Consultants, our one-time fee amounts to US\$950. The monthly rent thereafter will be paid independently and directly to the landlord by our Client. An estimate of such a rental for a space of 10 sqm for one employee is US\$1,100 per month;
14. If our Client and Healy Consultants properly plan this engagement, our Clients' will ***not*** have to travel during this engagement. Healy Consultants will efficiently and effectively complete company registration and corporate bank account opening in a timely manner without our Client presence. 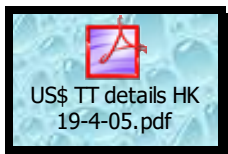
