To comply with this statutory requirement, Healy Consultants Group PLC' Burundi office will be the registered office address for your company. Thereafter, this address will be used to receive government correspondence including i) tax letters; ii) notice of the legal annual return; and iii) all government communications. Most of our Clients wish to place <u>Healy Consultants Group PLC' office address</u> on invoices, contracts, websites and business cards;
- 3. This fee is an estimate of government costs payable during your Firm's engagement. For transparency purposes, all government fee payments will be supported by original receipts and invoices. Examples of government costs include i) registration with the <u>Burundi Investment Promotion Agency</u> (API); ii) registration with the <u>Burundi Revenue Authority</u> (OBR) to obtain the NIF; iii) registration with the National Institute for Social Security and iv) making a company seal. Following engagement completion, Healy Consultants Group PLC will refund our Client any excess of funds received over actual Government costs paid;
- 4. Healy Consultants Group PLC will be pleased to open a Burundi corporate bank account without travel. As you can appreciate, it is a difficult task to obtain bank account approval through a newly formed company, when shareholders and directors and bank signatories reside overseas. All banks will be top tier banks in these countries with excellent internet banking services;

Furthermore, global banks now require evidence of proof of business in the country where the corporate bank account will be, including sales contracts or lease agreement;

- 5. This is Healy Consultants Group PLC fee to assist our Client obtain the Free-Trade Zone Regime status in Burundi. Healy Consultants Group PLC prepares a high quality free zone license application and submits to the <u>Burundi Ministry of Commerce</u> along with the company bylaws and incorporation documents together with a detailed business plan;
- 6. In accordance with Burundi Corporate Taxation Code, each entity must register for corporate tax and VAT at the <u>Burundi Revenue Authority;</u>
- 7. For an active trading company, these <u>accounting and tax</u> fees are an estimate of Healy Consultants Group PLC fees to efficiently and effectively discharge your annual company accounting and tax obligations. Following receipt of a set of draft accounting numbers from your company, Healy Consultants Group PLC will more accurately advise accounting and tax fees. For a dormant company, Healy Consultants Group PLC fees are only US\$950;
- 8. All fees quoted in this invoice correspond to fees quoted <u>on Healy Consultants Group PLC's website</u>. Please review this invoice carefully to identify errors. During the rush of the business day, it is possible that Healy Consultants Group PLC inadvertently made fee calculation errors, typing errors or omitted services or omitted historic fee payments from Clients. Free Trade Zone companies benefit from i) exemption from corporate tax for the first 10 years and a reduced rate of 15% thereafter; ii) exemption of withholding tax dividends for an unlimited period; iii) exemption from all import duties and taxes, direct or indirect, without an import license; and iv) permission to have foreign currency bank deposits and repatriate capital and income;
- 16. If required, Healy Consultants Group PLC will be pleased to assist your firm to secure employee visa approvals. Our fee is US\$4,950 for the first employee, US\$3,950 for the second employee, US\$2,950 per employee thereafter. Our employee visa fees includes preparation of a quality visa application and submitting to the correct Government immigration officers. The Government enjoys ultimate power of approval of visa applications. Consequently, guaranteed success is outside of Healy Consultants Group PLC' control. What is inside our control is the preparation and submission of a high quality immigration visa application that maximizes the likelihood of visa approval;
- 17. Burundi entities are only eligible for Free-Trade Zone regime if they i) export all the products; ii) create substantial added value to the country's economy; iii) comply with the environmental, health and safety regulations; and iv) receive Ministerial approval;
- 18. It is important our Clients are aware of their personal and corporate tax obligations in their country of residence and domicile. Let us know if you need Healy Consultants Group PLC help to clarify your local and international annual tax reporting obligations;
- 19. Some of our Clients request Healy Consultants Group PLC to provide temporary shared <u>office space</u> for 6 months until their preferred business premises is found. If your Firm requires this service, our one-time fee is US\$950. Monthly rental thereafter is paid directly to the landlord, independently of Healy Consultants Group PLC;
