Notes to invoice above

 Healy Consultants' fees to efficiently and effectively complete Isle of Man company registration within three weeks by i) choosing the optimum regulatory license for our Client's business activities ii) reserving a company name with the <u>Companies Registry</u> iii) settling our accountants' and lawyers' fees and iv) preparing a high quality company incorporation application for <u>Companies Registry</u>;

All <u>engagement fees</u> (click link) are agreed and paid up front and agree to the fees published on our country web pages. Consequently, there are no hidden fees, surprises or ambushes throughout the engagement. All engagement deadlines are agreed up front in the form of a <u>detailed project plan</u>, mapping out <u>deliverables</u> by week throughout the engagement term;



Every week during the engagement, Healy Consultants will email our Client a <u>detailed status</u> <u>update</u>. Our Client is immediately informed of engagement problems together with solutions. Your dedicated engagement manager is reachable by phone, Skype, live chat and email and will communicate in your preferred language;

2. In accordance with <u>Isle Of Man Companies Act - 2006</u>, each Isle of Man private limited company must appoint a company agent (similar to a company secretary), who may be a natural person or a body corporate, but the company agent must be resident in Isle Of Man. Healy Consultants will act as your Isle of Man Company Agent, for which our annual responsibilities include i) preparation and filing of the annual return; ii) securely maintaining company records; iii) liaising with the Isle of Man Government on behalf of our Client; iv) legal filing of changes of company structure; and v) ensuring company record compliance with local company law;

In accordance with <u>Isle Of Man Companies Act - 2006</u>, a private limited company shall as from the date of its incorporation have a legal registered office in Isle of Man, to which all official government communications and notices may be addressed. To comply with this statutory requirement, Healy Consultants' Isle of Man office will be the registered office address for your company. Thereafter, this address will be used to receive Government correspondence including a) annual and quarterly tax returns; b) bank statements and c) employee payroll tax and pension correspondence. Most of our Clients wish to place Healy Consultants <u>Isle of Man office address</u> (click link) on invoices, contracts, websites and business cards;

3. This fee is an estimate of government costs payable during your Firm's engagement. All government fee payments will be supported by original receipts and invoices. Examples of Government costs include i) reserving the company name with the Registrar of Companies; ii) filing the memorandum and articles of association with the Registrar of Companies; iii) having a Commissioner of Oaths authenticate forms, iv) apply for business licenses at the IOM corresponding authority and v) apply for social security with the Department of Health and Social security. Only the Registrar of Companies' fee is contemplated in this estimate for general purposes. Additional government costs will be charged to our Client as they appear. Following engagement completion, Healy Consultants will refund our Client any excess of funds received over actual Government costs paid;

To qualify as a 'tax exempt' company, an Isle of Man company is required to pay an annual fee of £380 to the Isle of Man government. Upon payment, the company's international income (i.e. outside the Isle of Man) is legally tax-free;

4. Healy Consultants will be pleased to open an Isle of Man corporate bank account without our Client travel. It is a time consuming task, and Healy Consultants will shelter our Client from the associated administrative challenges. As you can appreciate, it is a difficult task to obtain bank account approval through a newly formed company when shareholders, directors and bank signatories reside overseas. Healy Consultants will prepare a business plan for the bank to optimize the probability of corporate bank account approval. Depending on our Client's business and nationality, there is a 20% probability the banks will request a bank signatory to travel for a one hour bank interview. Healy Consultants will try its best to negotiate with the bank for a travel exemption. If our Client must travel to Isle of Man for corporate bank account opening, Healy Consultants will refund our Client £950;

If our Client is not comfortable with only an Isle of Mancorporate bank account, Healy Consultants will be pleased to open an international corporate bank account (click link) outside of the Isle of Man. Examples include New York, Germany, Liechtenstein, Austria, Bulgaria, South Africa, Australia, London, South America or Dubai. All banks will be top tier banks in these countries with excellent internet banking services. Example of our global banking partners include HSBC, Standard Chartered Bank, Citibank, Barclays, Standard bank, ANZ bank, VTB bank, UBS, Credit Suisse:

The banks enjoy ultimate power of approval of corporate bank account applications. Consequently, guaranteed success is outside of Healy Consultants' control. What is inside our control is the preparation and submission of a high quality bank application that maximizes the likelihood of

approval. To date, we enjoy a 100% approval record because of <u>our global banking relationships</u> and determination.







Global banks continue to tighten corporate bank account opening procedures, their internal compliance departments completing more thorough due diligence of Clients. Consequently, our Clients should expect the bank account approval period to take up to 4 weeks. Furthermore, global banks now require evidence of proof of business in the country where the corporate bank account will be, including sales contracts or lease agreement;

- 5. In accordance with <u>Isle Of Man Income Tax (Corporate Taxpayers) Act 2006</u>, each entity must register for corporate tax at the <u>Isle of Man tax authority</u>. VAT registration is mandatory for all Isle of Man companies with taxable supplier over £79,000, or selling any "digital services" to European individuals;
- 6. For an active trading company, these accounting and tax fees are an estimate of Healy Consultants fees to efficiently and effectively discharge your annual company accounting and tax obligations. Following receipt of a set of draft accounting numbers from your company, Healy Consultants will more accurately advise accounting and tax fees. For a dormant company, Healy Consultants fees are only £950;



- 7. All fees quoted in this invoice correspond to fees quoted on Healy Consultants' <u>business website</u>. Please review this invoice carefully to identify errors. During the rush of the business day, it is possible that Healy Consultants inadvertently made fee calculation errors, typing errors or omitted services or historic fee payments from Clients. In the unfortunate event you identify invoice errors, please revert to me directly re the same. I apologize in advance if I or my staff made invoice errors;

- **11.** In accordance with <u>Isle Of Man Companies Act 2006</u>, there is no minimum issued share capital required;
- 12. It is important our Clients are aware of their personal and corporate tax obligations in their country of residence and domicile, and that they will fulfil those obligations annually. Let us know if you need Healy Consultants help to clarify your local and international annual tax reporting obligations;
- 13. If our Client requires nominee shareholder and director <u>services (click link)</u>, Healy Consultants will be pleased to assist. Our fee for professional, passive nominee corporate shareholder amounts to £2,100 per annum. Our fee to be both nominee director and shareholder amounts to £6,600 per annum. Being the sole shareholders and sole director of a Client's company exposes Healy Consultants to reputation, litigation and financial risk;
- 14. If required, Healy Consultants will be pleased to assist your firm secure employee visa approvals for a fee of £4,950 for the first employee £3,950 for the second employee, £2,950 per employee thereafter. Our employee visa fees includes preparation of a quality visa application and submitting to the correct Government immigration officers. The Government enjoys ultimate power of approval of visa applications. Consequently, guaranteed success is outside of Healy Consultants' control. What is inside our control is the preparation and submission of a high quality immigration visa application that maximizes the likelihood of visa approval;

- 15. Monthly, quarterly and mid-year Government tax obligations include i) payroll reporting and ii) quarterly VAT and corporation tax return filing. If you need our help, Healy Consultants can complete monthly Government reporting for a monthly fee of £960. Healy Consultants monthly support will include i) receive in dropbox the monthly invoices from our client ii) label monthly bank statement transactions iii) preparation and submission of VAT returns and iv) monitor monthly profit levels to minimize annual tax v) submission of monthly employee payroll reporting;
- 16. Depending on our Client's business and nationality, the Isle of Man Government may require a special regulatory license to carry on your business in the country. Consequently, our Client should budget for possible additional translation and embassy attestation fees. Either our Client or Healy Consultants can complete this administrative task;
 - As always, Healy Consultants will negotiate with all third parties to eliminate or reduce additional engagement costs. For transparency purposes, all third party fee payments will be supported by original receipts and invoices. Examples of possible third party payments include i) embassy fees ii) notary public costs iii) official translator fees;
