In accordance with <u>OHADA Uniform Act</u>, a PLC shall as from the date of its incorporation have a legal registered office in CAR, to which all official government communications and notices may be addressed. To comply with this statutory requirement, Healy Consultants Group PLC's CAR office will be the registered office address for your company. Thereafter, this address will be used to receive government correspondence including i) tax letters; ii) notice of the legal annual return and iii) all government communications. Most of our Clients wish to place <u>Healy Consultants Group PLC's office address</u> on invoices, contracts, websites and business cards;

- 3. This fee is an estimate of government costs payable during your Firm's engagement. For transparency purposes, all government fee payments will be supported by original receipts and invoices. Examples of government costs include i) procurement of the director's residence certificate; ii) registering the company with <u>Guichet Unique de formalité des Entreprises</u> (GUFE); iii) registering the company with the <u>Chamber of Commerce</u> and iv) obtaining a business license from the municipality. For an active trading company, these <u>accounting and tax</u> fees are an estimate of Healy Consultants Group PLC fees to efficiently and effectively discharge your annual company accounting and tax obligations. Following receipt of a set of draft accounting numbers from your company, Healy Consultants Group PLC will more accurately advise accounting and tax fees. For a dormant company, Healy Consultants Group PLC fees are only US\$950;
- 7. All fees quoted in this invoice correspond to fees quoted <u>on Healy Consultants Group PLC's website</u>. Please review this invoice carefully to identify errors. However, the Government enjoys ultimate power of approval of company registrations and business licenses;
- 14. It is compulsory for every CAR company to appoint a resident representative. To minimize complexity, Healy Consultants Group PLC recommends our Client appoint one staff member already in CAR. If our Client is uncomfortable or unable to adopt this strategy, Healy Consultants Group PLC will provide nominee services. Our annual fee for the same is US\$6,600 per nominee;
- 15. If our Client requires nominee shareholder and director <u>services</u>, Healy Consultants Group PLC will be pleased to assist. Our fee for professional, passive nominee corporate shareholder amounts to US\$2,100 per annum. Our fee to be both nominee director and shareholder amounts to US\$6,600 per annum.
