1. Healy Consultants Group PLC fees to efficiently and effectively complete Massachusetts Corporation registration within [5 weeks \(click link\)](#) by **i)** choosing the optimum regulatory license for our Client's business activities; **ii)** reserving the entity name at the [Secretary of Commonwealth website](#); **iii)** settling our accountant and lawyer fees and **iv)** preparing a high quality corporation registration application for submission to the Secretary of the Commonwealth;

All [engagement fees](#) (click link) are agreed and paid up front and agree to the fees published on our country web pages. Consequently, there are no hidden fees, surprises or ambushes throughout the engagement. All engagement deadlines are agreed up front in the form of a [detailed project plan](#), mapping out [deliverables](#) by week throughout the engagement term;



Every week during the engagement, Healy Consultants Group PLC will email our Client a [detailed status update](#). Our Client is immediately informed of engagement problems together with solutions. In accordance with the [Massachusetts Business Corporations Act](#), each Massachusetts Corporation must appoint a registered agent, who may be a natural person or a body corporate, but the agent must be resident in the country. Healy Consultants Group PLC will act as your Massachusetts corporation agent, our annual responsibilities include **i)** preparing and filing the legal annual return; **ii)** securely maintaining corporation records; **iii)** liaising with the government on our Client's behalf; **iv)** legal filing of changes of corporate structure and **v)** reminding our Client of statutory deadlines;

In accordance with [Massachusetts Business Corporations Act](#), a Corporation shall as from the date of its incorporation have a legal registered office in Massachusetts, to which all official government communications and notices may be addressed. To comply with this statutory requirement, Healy Consultants Group PLC' Massachusetts office will be the registered office address for your corporation. Thereafter, this address will be used to receive government correspondence including **i)** tax letters **ii)** notice of the legal annual return; and **iii)** all government communications. Most of our Clients wish to place [Healy Consultants Group PLC' office address](#) on invoices, contracts, websites and business cards;

3. This fee is an estimate of government costs payable during your firm's engagement. All government fee payments will be supported by original receipts and invoices. Examples of government costs include **i)** reserving the [corporation name](#); **ii)** submitting the [corporation incorporation forms](#) and **iii)** applying for a Certificate of Good Standing. Following engagement completion, Healy Consultants Group PLC will refund our Client any excess of funds received over actual Government costs paid;
4. Healy Consultants will be pleased to open a [US corporate bank account](#) without travel. Depending on our Client business and nationality, there is a 20% probability the banks will request a bank signatory to travel for a one-hour bank interview. If our Client must travel to the States for corporate bank account opening, Healy Consultants Group PLC will refund our Client US\$950;

Example of our global banking partners include HSBC, Standard Chartered Bank, Citibank, Barclays, Standard bank, ANZ bank, VTB bank, UBS, Credit Suisse;



What is inside our control is the preparation and submission of a high-quality bank application that maximizes the likelihood of approval. Global banks continue to tighten corporate bank account opening procedures, their internal compliance departments completing more thorough due diligence of Clients. Consequently, our Clients should expect the bank account approval period to take up to 4 weeks. Furthermore, global banks now require evidence of proof of business in the country where the corporate bank account will be, including sales contracts or lease agreement;

5. In accordance with [Internal Revenue Service \(IRS\)](#) guidelines, each entity must register for tax by applying for an [Employee Identification Number \(EIN\)](#). Furthermore, all companies which wish to sell tangible property in Massachusetts must [register for sales tax](#). Healy Consultants Group PLC will be happy to assist you with registration for corporate tax and sales tax for a one-time fee of US\$750;
6. For an active trading entity, these [accounting and tax](#) fees are an estimate of Healy Consultants Group PLC fees to efficiently and effectively discharge your annual accounting and tax obligations. Following receipt of a set of draft accounting numbers from your company, Healy Consultants Group PLC will more accurately advise accounting and tax fees. For a dormant entity, Healy Consultants Group PLC fees are only US\$950;

Our fee for professional, passive nominee corporate shareholder amounts to US\$2,100 per annum. Our fee to be both nominee director and shareholder amounts to US\$6,600 per annum.
