- 13. It is compulsory for every Rwanda branch to appoint a local auditor. To minimize complexity, Healy Consultants Group PLC recommends our Client appoint one staff member already in Rwanda. If our Client is uncomfortable or unable to adopt this strategy, Healy Consultants Group PLC will provide nominee services. Our annual fee for the same is US\$6,600 per nominee;
- 14. If our Client and Healy Consultants Group PLC properly plan this engagement, our Clients will <u>not</u> have to travel during this engagement.
