Notes to invoice above

1. Healy Consultants fees to efficiently and effectively complete Zimbabwe representative office registration within two months by **i)** choosing the optimum regulatory license for our Client's business activities **ii)** reserving a name with the [Registrar of Companies](#) **iii)** settling our accountant and lawyer fees and **iv)** preparing a high quality representative office registration application for the [Registrar of Companies](#);

All [engagement fees](#) (click link) are agreed and paid up front and agree to the fees published on our country web pages. Consequently, there are no hidden fees, surprises or ambushes throughout the engagement. All engagement deadlines are agreed up front in the form of a [detailed project plan](#), mapping out [deliverables](#) by week throughout the engagement term;



Every week during the engagement, Healy Consultants will email our Client a [detailed status update](#). Our Client is immediately informed of engagement problems together with solutions. Your dedicated engagement manager is reachable by phone, Skype, live chat and email and will communicate in your preferred language;

2. In accordance with the [Zimbabwe Companies Act](#), each representative office of a foreign company shall as from the date of its registration have a legal registered office in Zimbabwe, to which all official government communications and notices may be addressed. To comply with this statutory requirement, Healy Consultants' Zimbabwe office will be the registered office address for your representative office. Thereafter, this address will be used to receive government correspondence including **i)** tax letters **ii)** notice of the legal annual return; and **iii)** all government communications. Most of our Clients wish to place [Healy Consultants' office address](#) on invoices, contracts, websites and business cards;
3. Healy Consultants will be pleased to open a Zimbabwe corporate bank account without our Client travel. It is a time consuming task, and Healy Consultants will shelter our Client from the associated administrative challenges. As you can appreciate, it is a difficult task to obtain bank account approval through a newly formed representative office when shareholders, directors and bank signatories reside overseas. Healy Consultants will prepare a business plan for the bank to optimize the probability of corporate bank account approval. Depending on our Client's business and nationality, there is a 20% probability the banks will request a bank signatory to travel for a one hour bank interview. Healy Consultants will try its best to negotiate with the bank for a travel exemption. If our Client must travel to Zimbabwe for corporate bank account opening, Healy Consultants will refund our Client US\$950;

If our Client is not comfortable with only a Zimbabwe corporate bank account, Healy Consultants will be pleased to open [an international corporate bank account](#) (click link) outside of Zimbabwe. Examples include New York, Germany, Liechtenstein, Austria, Bulgaria, South Africa, Australia, London, South America or Dubai. All banks will be top tier banks in these countries with excellent internet banking services. Example of our global banking partners include HSBC, Standard Chartered Bank, Citibank, Barclays, Standard bank, ANZ bank, VTB bank, UBS, Credit Suisse;

The banks enjoys ultimate power of approval of corporate bank account applications. Consequently, guaranteed success is outside of Healy Consultants' control. What is inside our control is the preparation and submission of a high quality bank application that maximizes the likelihood of approval. To date, we enjoy a 100% approval record because of [our global banking relationships](#) and determination.




Global banks continue to tighten corporate bank account opening procedures, their internal compliance departments completing more thorough due diligence of Clients. Consequently, our Clients should expect the bank account approval period to take up to 4 weeks. Furthermore, global banks now require evidence of proof of business in the country where the corporate bank account will be, including sales contracts or lease agreement;

4. This fee is an estimate of government costs payable during your Firm's engagement. For transparency purposes, all government fee payments will be supported by original receipts and invoices. Examples of government costs include **i)** reserving the foreign company name with the Chief Registrar of Companies, **ii)** filing the M&AA of the foreign head office with the [Registrar of Companies](#); **iii)** registering with the tax authorities for income tax, VAT and PAYE; **iv)** submitting a business license application to the [Zimbabwean Investment Authority](#); **v)** submitting an application for a municipal license and **vi)** the Zimbabwe Investment Authority. Following engagement completion, Healy Consultants will refund our Client any excess of funds received over actual Government costs paid;
5. The [Zimbabwean Investment Authority](#) requires all foreign-owned businesses to gain an investment licence following incorporation. This is Healy Consultants' fee to project manage the ZIA licensing process, which is in addition to the fees charged by the government (included in the "Government Fees" above). This fee is exclusive of any secondary licences required for our Client's specific business activities;
6. In accordance with Zimbabwe law, each entity must register for corporate tax and VAT at the [Zimbabwe Revenue Authority](#);

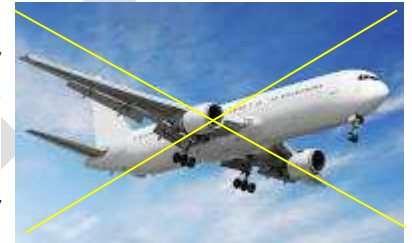
7. For an active trading representative office, these [accounting and tax](#) fees are an estimate of Healy Consultants fees to efficiently and effectively discharge annual accounting and tax obligations. Following receipt of a set of draft accounting numbers from your representative office, Healy Consultants will more accurately advise accounting and tax fees. For a dormant representative office, Healy Consultants fees are only US\$950;

 9. Assuming our Clients re-engage Healy Consultants in year 2, this fee is an estimate of the fees payable next year, 12 months after the date of representative office registration;
 10. The fees quoted in this invoice are a prediction of the fees required to efficiently and effectively complete this engagement in a timely manner. If during the engagement Healy Consultants realizes that the project is more complex than anticipated, requiring a large additional investment of time, my Firm will revert to request additional fees. If Healy Consultants completes the engagement faster and more easily than expected, Healy Consultants is happy to refund some fees to our Client;
 11. Several industries in Zimbabwe are restricted to foreign investment and foreigners willing to start a business will be required to form a joint venture with a local. See [this link](#) for a list of industries where this requirement applies. If our Client's industry is included in the list, he will be forbidden to register a representative office and can register instead a joint venture company;
 12. Representative office business activities are limited to marketing and promotion activities. A representative office can employ a maximum of 10 employees. A representative office can or cannot i) issue sales invoice to Clients and iii) sign local legal contracts. A representative office cannot import and export goods;
 13. Engage Healy Consultants to [project manage](#) business set up in every country on the planet. We are the best in the [world](#) at what we do, timely completing [the A to Z](#) of every country engagement;

14. In accordance with Zimbabwe Company Law, a minimum deposit of US\$100 must be injected to the representative office's corporate bank account after representative office registration. This amount can be higher depending on the nature of the business of our Client. To optimize engagement efficiency and minimize delays, Healy Consultants is happy to deposit these funds on behalf of our clients;
15. In accordance with Zimbabwe Laws, each representative office of a foreign company must have at least one individual country representative ordinarily resident in Zimbabwe. If required, Healy Consultants will be pleased to provide your firm with a professional nominee representative in Zimbabwe. Our fee amounts to US\$5,000 per annum;
16. If our Client and Healy Consultants properly plan this engagement, our Clients' will **not** have to travel during this engagement. Healy Consultants will efficiently complete representative office registration and corporate bank account opening in a timely manner without our Client presence. Instead, our Client will need to **i)** sign and get documents legalized in the embassy in their country of origin and **ii)** courier the originals to Healy Consultants office;
17. Depending on our Client's business and nationality, the [country] Government may require a special regulatory license to carry on your business in the country. Healy Consultants will assist our Client secure license approval; there may be additional engagement fees. However, the Government enjoys ultimate power of approval of representative office registration and business licenses;
18. If required, Healy Consultants will be pleased to assist your Firm to secure employee visa approvals. Our fee is US\$2,950 for the first employee, US\$1,950 for the second employee, US\$950 per employee thereafter. Our employee visa fees includes preparation of a quality visa application and submitting to the correct Government immigration officers. The Government enjoys ultimate power of approval of visa applications. Consequently, guaranteed success is outside of Healy Consultants' control. What is inside our control is the preparation and submission of a high quality visa application that maximizes the likelihood of visa approval;
19. Some of our Clients request Healy Consultants to provide temporary shared [office space](#) for 6 months until their preferred business premises is found. If your Firm requires this service, our one-time fee is US\$950. Monthly rental thereafter is paid directly to the landlord, independently of Healy Consultants;
20. It is important our Clients are aware of their personal and corporate tax obligations in their country of residence and domicile. Let us know if you need Healy Consultants help to clarify your local and international annual tax reporting obligations;

21. Monthly, quarterly and mid-year Government tax obligations include monthly and quarterly payroll reporting, VAT and corporate income tax return filing. If you need our help, Healy Consultants can complete monthly Government reporting for a monthly fee of US\$860. Healy Consultants monthly support will include **i)** receive in dropbox the monthly invoices from our client **ii)** label monthly bank statement transactions **iii)** preparation and submission of VAT returns and **iv)** submission of monthly employee payroll reporting;
22. During the engagement, shareholders and directors' documents may need to be translated into the local language; before the Government and Bank approves representative office registration and corporate bank account opening respectively. Consequently, our Client should budget for possible additional translation and embassy attestation fees. Either our Client or Healy Consultants can complete this administrative task;

As always, Healy Consultants will negotiate with all third parties to eliminate or reduce additional engagement costs. For transparency purposes, all third party fee payments will be supported by original receipts and invoices. Examples of possible third party payments include **i)** embassy fees **ii)** notary public costs **iii)** official translator fees;
23. Some of our Clients require an [immediate country solution](#). With this strategy, within a day Healy Consultants can supply our Client **i)** an existing dormant Zimbabwe company number and **ii)** an already approved Zimbabwe corporate bank account number and **iii)** a business address. 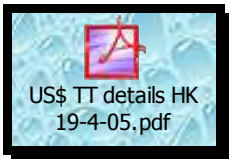
