In accordance with the Malaysian Limited Liability Partnership Act of 2012 (click here), a partnership shall as from the date of its registration have a legal registered office in Malaysia, to which all official Government communications and notices may be addressed. To comply with this statutory requirement, Healy Consultants Group PLC's Malaysia business office will be the registered office address for your Malaysia partnership. Thereafter, this address will be used to receive Government correspondence including i) annual returns; ii) bank statements and iii) employee payroll tax and pension correspondence. Most of our Clients wish to place Healy Consultants Group PLC's office address on invoices, contracts, websites and business cards;

3. This fee is an estimate of Government costs payable during your Firm's engagement. For transparency purposes, all government fee payments will be supported by original receipts and invoices. If the Client wishes to apply for i) work permit for expatriate ii) special license, the issued and paid up contribution must be increased to U\$140,000 (equivalent to RM500,000). During the engagement, shareholders and directors' documents may need to be translated into the local language; before the Government and Bank approves partnership registration and corporate bank account opening respectively. - 14. Monthly and mid-year Government tax obligations include i) monthly payroll reporting and ii) bi-monthly SST filing. If you need our help, Healy Consultants Group PLC can complete monthly Government reporting for a monthly fee of US\$920.
