## Notes to invoice above

1. Healy Consultants fees to efficiently and effectively complete Bermuda exempted LP registration within [3 weeks](#) by **i)** choosing the optimum M&AA for our Client's business activities **ii)** reserving the business name with the [Bermuda Registrar of Companies](#) (ROC) **iii)** settling our accountant and lawyer fees and **iv)** preparing a high quality LLP registration application for ROC;

All [engagement fees](#) (click link) are agreed and paid up front and agree to the fees published on our country web pages. Consequently, there are no hidden fees, surprises or ambushes throughout the engagement. All engagement deadlines are agreed up front in the form of a [detailed project plan](#), mapping out [deliverables](#) by week throughout the engagement term;



Every week during the engagement, Healy Consultants will email our Client a [detailed status update](#). Our Client is immediately informed of engagement problems together with solutions. Your dedicated engagement manager is reachable by phone, Skype, live chat and email and will communicate in your preferred language;

2. In accordance with [Section 10 of Exempted Partnerships Act 1992](#), each Bermuda LP shall as from the date of its registration have a legal registered office in Bermuda, to which all official Government communications and notices may be addressed. To comply with this statutory requirement, Healy Consultants Group will supply a Bermuda business office as the registered office address for your Bermuda LP. Thereafter, this address will be used to receive Government correspondence including **a)** bank statements and **b)** employee payroll tax and pension correspondence. Most of our Clients wish to place their Bermuda office address on invoices, contracts, websites and business cards;
3. Healy Consultants will be pleased to open a Bermuda corporate bank account without travel. It is a time consuming task, Healy Consultants will shelter our Client from the administrative challenges. As you can appreciate, it is a difficult task to obtain bank account approval through a newly formed LP, when partners, managers and bank signatories reside overseas. Healy Consultants will prepare a business plan for the bank to optimize the probability of corporate bank account approval. Depending on our Client business and nationality, there is a 20% probability the banks will request a bank signatory to travel for a one-hour bank interview. Healy Consultants will try its best to negotiate with the bank for a travel exemption. If our Client must travel to Bermuda for corporate bank account opening, Healy Consultants will refund our Client US\$950;

If our Client is not comfortable with only a Bermuda corporate bank account, Healy Consultants will be pleased to open [an international corporate bank account](#) (click link) outside of Bermuda. Examples include New York, Germany, Liechtenstein, Austria, Bulgaria, South Africa, Australia, London, South America or Dubai. All banks will be top tier banks in these countries with excellent internet banking services. Example of our global banking partners include HSBC, Standard Chartered Bank, Citibank, Barclays, ABN Amro, Bank of China, ANZ bank, Standard Bank, UBS, Credit Suisse;

The banks enjoys ultimate power of approval of corporate bank account applications. Consequently, guaranteed success is outside of Healy Consultants' control. What is inside our control is the preparation

and submission of a high quality bank application that maximizes the likelihood of approval. To date, we enjoy a high approval record because of [our global banking relationships](#) and determination.



Global banks continue to tighten corporate bank account opening procedures, their internal compliance departments completing more thorough due diligence of Clients. Consequently, our Clients should expect the bank account approval period to take up to 4 weeks. Furthermore, global banks now require evidence of proof of business in the country where the corporate bank account will be, including sales contracts or lease agreement;

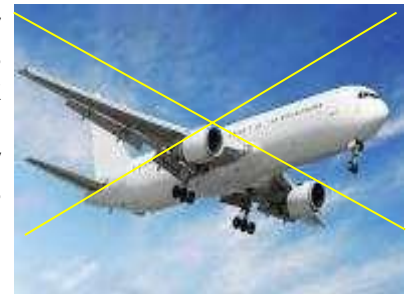
4. For an active trading LP, these accounting and tax fees are an estimate of Healy Consultants fees to efficiently and effectively discharge your annual accounting and tax obligations. Following receipt of a set of draft accounting numbers from your LP, Healy Consultants will more accurately advise accounting and tax fees. For a dormant LP, Healy Consultants fees are only US\$950;
5. All fees quoted in this invoice correspond to fees quoted [on Healy Consultants' website](#). Please review this invoice carefully to identify errors. During the rush of the business day, it is possible that Healy Consultants inadvertently made fee calculation errors, typing errors or omitted services or omitted historic fee payments from Clients. In the unfortunate event you identify invoice errors, please revert to me directly re the same. I apologize in advance if I or my staff made invoice errors;
6. Assuming our Clients re-engage Healy Consultants in year 2, this fee is an estimate of the fees payable next year, 12 months after the date of company registration;
7. The fees quoted in this invoice are a prediction of the fees required to efficiently and effectively complete this engagement in a timely manner. If during the engagement Healy Consultants realizes that the project is more complex than anticipated, requiring a large additional investment of time, my Firm will revert to request additional fees. If Healy Consultants completes the engagement faster and more easily than expected, Healy Consultants is happy to refund some fees to our Client;
8. In accordance with [Section 17 of Exempted Partnership Act 1992](#), each Bermuda Partnership must have at least one individual country representative ordinarily resident in Bermuda. If required, Healy Consultants

will be pleased to provide your firm with a professional nominee representative in Bermuda Our fee amounts to US\$6,600 per annum;

9. Some of our Clients require an immediate Bermuda solution. With this strategy, within a day Healy Consultants can supply our Client **i)** an existing dormant Bermuda company number and **ii)** an already approved Bermuda corporate bank account number and **iii)** a business address. Turnkey solutions are attractive to those entrepreneurs who wish to immediately close a country deal, sign a contract or invoice a customer;
10. In accordance with [Bermuda Partnership Act 1902](#) there is a minimum capital contribution of foreign currency equivalent of BM\$12,000 for formation of a Bermuda LP;
11. A Bermuda exempted partnership is only allowed to conduct trading activities with overseas customers. It cannot conduct productive or commercial operations within Bermuda and with Bermuda residents;
12. Healy Consultants will be pleased to assist your LP obtain work permit approvals. Our fee is US\$3,950 for the first employee, US\$2,950 for the second employee, US\$1,950 per employee thereafter. Our employee visa fees includes preparation of a quality visa application and submitting to the correct Government immigration officers. The Government enjoys ultimate power of approval of visa applications. Consequently, guaranteed success is outside of Healy Consultants' control. What is inside our control is the preparation and submission of a high quality immigration visa application that maximizes the likelihood of visa approval;
13. If our Client and Healy Consultants properly plan this engagement, our Clients will ***not*** have to travel during this engagement. Healy Consultants will efficiently and effectively complete LLP registration and corporate bank account opening in a timely manner without our Client presence. Instead, our Client will need to **i)** sign and get documents legalized in the embassy in their country of origin and **ii)** courier the originals to Healy Consultants office;
14. Depending on our Client business and nationality, the Bermuda Government may require a special regulatory license to carry on your business in the country. Healy Consultants will assist our Client secure license approval. However, the Government enjoys ultimate power of approval of LP registrations and business licenses;
15. If our Client requires nominee partner or manager [services \(click link\)](#), Healy Consultants will be pleased to assist. Our fee for professional, passive nominee corporate limited partner amounts to US\$2,100 per annum. Our fee to be both nominee manager and limited partner amounts to US\$6,600 per annum. Being the sole manager and sole partner of a Client's LLP exposes Healy Consultants to reputation, litigation and financial risk;

16. Monthly, quarterly and mid-year Government tax obligations include monthly and quarterly payroll reporting, VAT and withholding tax return filing. If you need our help, Healy Consultants can complete monthly Government reporting for a monthly fee of US\$860. Healy Consultants monthly support will include **i)** receive in dropbox the monthly invoices from our client **ii)** label monthly bank statement transactions **iii)** preparation and submission of VAT returns and **iv)** submission of monthly employee payroll reporting;

During the engagement, shareholders and directors' documents may need to be translated into the local language; before the Government and Bank approves LP registration and corporate bank account opening respectively. Consequently, our Client should budget for possible additional translation and embassy attestation fees. Either our Client or Healy Consultants can complete this administrative task;
