Depending on the specific nature of the business of our Client, the [Shannon Zone authority](#) can require our Client to obtain a manufacturing license before our Client is legally allowed to commence manufacturing operations. 14. In accordance with [EU VAT Law](#), an Irish company is obliged to register for VAT if annual sales exceed €55,000 or is expected to exceed €55,000 in any calendar year. Healy Consultants Group PLC will be happy to assist you with VAT registration for a onetime fee of €850;
