1. In accordance with <a href="Mexico Taxation Laws">Mexico Taxation Laws</a>, each entity must register for corporate tax and VAT with the <a href="Secretariat of Finance and Public Credit">Secretariat of Finance and Public Credit</a>. Usually, it takes <a href="One week">One week</a> to secure tax numbers;


