Notes to invoice above:

1. Healy Consultants Group PLC Group PLC's fees to legally register our Client South Africa LLC with our temporary professional, passive nominee <u>shareholders and directors</u> and bank signatory. Within <u>2 weeks</u>, my team and I will email you i) a company registration number ii) a corporate bank account number iii) a city center business address iv) a tax number and iv) a proforma South Africa sales invoice template complying with South Africa company law;

Within 5 weeks, our Client can legally conduct business in South Africa; including i) issue sales invoices to local customers ii) sign customer and supplier contracts iii) sign a lease agreement for long term physical office and warehouse premises iv) and hire local and expatriate employees including secure employment visa approval;

All engagement fees are agreed and paid up front and agree to the fees published on our country web pages (click link). Consequently, there are no hidden fees nor surprises nor ambushes throughout the engagement. All engagement deadlines are agreed up front in the form of a detailed project plan, mapping out deliverables by week throughout the engagement term;

- 3. In accordance with South Africa law, each entity must register for corporate tax and VAT with the South African Revenue Service (SARS). usually, it takes 1 week to secure tax numbers;

It is a time-consuming task; Healy Consultants Group PLC will shelter our Client from the administrative hurdles. In accordance with <u>South African Companies Act</u>, all South Africa companies must have i) 1 shareholder and ii) 1 director of which 1 appointed as a public officer needs to be resident in South Africa. Appointment of Healy Consultants Group PLC Group PLC professional, passive <u>nominee shareholders</u> and <u>directors</u> (click links) and bank signatory enables Our Client to i) sales invoice customers within 5 weeks and ii) sign contracts and lease premises;



To optimize engagement efficiency and minimize delays, Healy Consultants Group PLC is happy to deposit these funds on behalf of our Clients;
- 14. Monthly and quarterly Government tax obligations include i) payroll and personal income tax reporting on behalf of employees (if any) ii) monthly VAT returns and payments iii) quarterly report over the use of the invoice book and iv) quarterly corporate tax provisional payments. However, the Government enjoys ultimate power of approval of company corporate structure changes and business licenses;
- 18. During the engagement, shareholders and directors documents may need to be translated into English, before the Government and Bank approves corporate structure changes and bank account signatory change respectively. Consequently, our Client should budget for possible additional translation and embassy atestation fees. Either our Client or Healy Consultants Group PLC can complete this administrative task;
