 Healy Consultants' fees to efficiently and effectively complete Belize LP registration within 2 weeks by i) choosing the optimum regulatory license for our Client's business activities ii) reserving a partnership name with <u>Registry of Corporate Affairs</u> iii) settling our accountant and lawyer fees and iv) preparing a high quality partnership incorporation application for <u>Registry of Corporate Affairs</u>;

All <u>engagement fees</u> (click link) are agreed and paid up front and agree to the fees published on our country web pages. Consequently, there are no hidden fees or surprises or ambushes throughout the engagement. All engagement deadlines are agreed up front in the form of <u>a detailed project</u> <u>plan</u>, mapping out deliverables by week throughout the engagement term;



Every second day during the engagement, we email our Client a <u>detailed email engagement</u> <u>status update</u>. Our Client is immediately informed of engagement problems together with solutions. Thereafter, this address will be used to receive Government correspondence;

3. This fee is an estimate of Government costs to complete your Firm's engagement. For transparency purposes, all government fee payments will be supported by original receipts and invoices. Examples of Government costs include i) reserving the partnership name with the <u>Registry of Corporate Affairs</u>; ii) preparation of a Partnership Agreement and iii) applying for trade registration at the <u>City Council</u> and iv) preparation of the partnership seal. Following engagement completion, Healy Consultants will refund our Client any excess of funds received over actual Government costs paid;

4. Healy Consultants will be pleased to open <u>an international corporate bank account</u> (click link) outside of Belize. Examples include New York, Germany, Liechtenstein, Austria, Bulgaria, South Africa, Australia, London, South America or Dubai. All banks will be top tier banks in these countries with excellent internet banking services. Example of our global banking partners include HSBC, Standard Chartered Bank, Citibank, Barclays, Standard bank, ANZ bank, VTB bank, UBS, Credit Suisse;

It is a time consuming task, Healy Consultants will shelter our Client from the administrative challenges. As you can appreciate, it is a difficult task to obtain bank account approval through a newly formed partnership, when partners and bank signatories reside overseas. Healy Consultants will prepare a business plan for the bank to optimize the probability of corporate bank account approval. Depending on our Client business and nationality, there is a 20% probability the banks will request a bank signatory to travel for a one hour bank interview. Healy Consultants will try its best to negotiate with the bank for a travel exemption. If our Client must travel to the country for corporate account opening, Healy Consultants will refund our Client US\$ 950;

Global banks continue to tighten hedge fund bank account opening procedures, their internal compliance departments completing more thorough due diligence of Clients. Consequently, our Clients should expect the bank account approval period to take up to 4 weeks. Furthermore, global banks now require evidence of proof of business in the country where the hedge fund bank account will be, including sales contracts or lease agreement;

5. For an active trading partnership, these <u>accounting and tax</u> fees are an estimate of Healy Consultants fees to efficiently discharge your annual partnership accounting and tax obligations. Following receipt of a set of draft accounting numbers from your partnership, Healy Consultants will more accurately advise accounting and tax fees. For a dormant partnership, Healy Consultants fees are only US\$950;

If during the engagement Healy Consultants realizes that the project is more complex than anticipated, requiring a large additional investment of time, my Firm will revert to request additional fees. - 12. Depending on our Client business and nationality, the Belize Government may require a special regulatory license to carry on your business in the country. Healy Consultants will assist our Client secure license approval. However, the Government enjoys ultimate power of approval of partnership registrations and business licenses;
- 13. It is important our Clients' are aware of their personal and corporate tax obligations in their country of residence and domicile; and they will fulfill those obligations annually. Let us know if you need Healy Consultants help to clarify your local and international annual tax reporting obligations;
- 14. During the engagement, shareholders and directors documents may need to be translated into the local language before the Government and Bank approves partnership registration and corporate bank account opening respectively. Consequently, our Client should budget for possible additional translation and embassy atestation fees. Either our Client or Healy Consultants can complete this administrative task;

As always, Healy Consultants will negotiate with all third parties to eliminate or reduce additonal engagement costs. For transparency purposes, all third party fee payments will be supported by original receipts and invoices. Examples of possible third party payments include i) embassy fees ii) notary public costs iii) official translator fees;
