1. Healy Consultants Group PLC' fees to efficiently and effectively complete Luxembourg company registration within [3 weeks](#) by **i)** choosing the optimum regulatory license for our Client's business activities **ii)** reserving a company name with the [Chamber of Commerce](#) **iii)** settling our accountants' and lawyers' fees and **iv)** preparing a high quality company incorporation application for [the Chamber of Commerce](#);

All [engagement fees](#) (click link) are agreed and paid up front and agree to the fees published on our country web pages. Consequently, there are no hidden fees, surprises or ambushes throughout the engagement. All engagement deadlines are agreed up front in the form of a [detailed project plan](#), mapping out [deliverables](#) by week throughout the engagement term;



Every week during the engagement, Healy Consultants Group PLC will email our Client a [detailed status update](#). Our Client is immediately informed of engagement problems together with solutions. Your dedicated engagement manager is reachable by phone, Skype, live chat and email and will communicate in your preferred language;

2. In accordance [Luxembourg Company Law 1915](#), each SARL shall as from the date of its incorporation have a legal registered office in Luxembourg, to which all official government communications and notices may be addressed. To comply with this statutory requirement, Healy Consultants Group PLC' Luxembourg office will be the registered office address for your company. Thereafter, this address will be used to receive Government correspondence including **i)** the annual tax return, **ii)** notice of the annual return; and **iii)** notice of government audits. Most of our Clients wish to place Healy Consultants Group PLC [Luxembourg office address \(click link\)](#) on invoices, contracts, websites and business cards;
3. This fee is an estimate of Government costs to complete your Firm's engagement. All Government fee payments will be supported by original receipts and invoices. Examples of Government costs include include **i)** registering the company at the Register of Commerce and Companies; **ii)** paying the fixed specific registration fee to the Land Registration and Estates Department; **iii)** paying the stamp duty for the business permit; and **iv)** obtaining a LuxTrust certificate. Following engagement completion, Healy Consultants Group PLC will refund our Client any excess of funds received over actual Government costs paid;

4. To obtain a business permit, which is required in order to conduct business within Luxembourg, each Luxembourg SARL must have at least one individual director ordinarily resident in Luxembourg and responsible for managing the company. If required, Healy Consultants Group PLC can provide you a professional passive nominee director for an annual fee of €11,850 per nominee;
5. Healy Consultants Group PLC will be pleased to open a Luxembourg corporate bank account without our Client travel. It is a time consuming task, and Healy Consultants Group PLC will shelter our Client from the associated administrative challenges. As you can appreciate, it is a difficult task to obtain bank account approval through a newly formed company when shareholders, directors and bank signatories reside overseas. Healy Consultants Group PLC will prepare a business plan for the bank to optimize the probability of corporate bank account approval. Depending on our Client's business and nationality, there is a 20% probability the banks will request a bank signatory to travel for a one hour bank interview. Healy Consultants Group PLC will try its best to negotiate with the bank for a travel exemption. If our Client must travel to Luxembourg for corporate bank account opening, Healy Consultants Group PLC will refund our Client €950;

If our Client is not comfortable with only a Luxembourg corporate bank account, Healy Consultants Group PLC will be pleased to open [an international corporate bank account](#) (click link) outside of Luxembourg. Examples include New York, Germany, Liechtenstein, Austria, Bulgaria, South Africa, Australia, London, South America or Dubai. All banks will be top tier banks in these countries with excellent internet banking services. Example of our global banking partners include HSBC, Standard Chartered Bank, Citibank, Barclays, Standard bank, ANZ bank, VTB bank, UBS, Credit Suisse;

The banks enjoy ultimate power of approval of corporate bank account applications. Consequently, guaranteed success is outside of Healy Consultants Group PLC' control. What is inside our control is the preparation and submission of a high-quality bank application that maximizes the likelihood of approval. To date, we enjoy a 100% approval record because of [our global banking relationships](#) and determination.

Global banks continue to tighten corporate bank account opening procedures, their internal compliance departments completing more thorough due diligence of Clients. Consequently, our Clients should expect the bank account approval period to take up to 4 weeks. Furthermore, global banks now require evidence of proof of business in the country where the corporate bank account will be, including sales contracts or lease agreement;

6. Healy Consultants Group PLC to assist our Client to secure the license required for the company to become a mixed holding company that combines commercial activity with holding equities in companies worldwide (Société de Participation Financière or “SOPARFI”). This type of company allows tax exemption for **i)** dividends, **ii)** capital gains on sales of equity holdings and **iii)** liquidation surpluses.

It is mandatory for a Luxembourg holding company carrying on commercial activities as its primary or secondary activity to obtain a trade license ([autorisation d'établissement](#)). This fees also includes Healy Consultant Group PLC's fees for **i)** choosing and paying the optimum regulatory license; **ii)** preparing a high-quality license application for the [General Directorate for SMEs and Entrepreneurship](#) and **iii)** prepare a detailed business plan. The license fee may vary depending on the company business activity;

7. In accordance with Luxembourg law, each entity must register for tax at the [Land Registration and Estates Department](#). A SOPARFI company will be liable to pay an annual subscription tax at a rate of 0.25% and VAT registration might not be needed. Healy Consultants will be happy to assist your firm with tax registration and VAT for a one time fee of €950;
8. In order to obtain a business permit, which is required in order to conduct business within Luxembourg, each Luxembourg SARL must have at least one individual director resident in Luxembourg and responsible for managing the company. If required, Healy Consultants can provide you a professional passive nominee director for an annual fee of €11,850 per nominee. As an SOPARFI company is not permitted to conduct business, a business permit is not required;
9. For an active holding company, these [accounting and tax](#) fees are an estimate of Healy Consultants Group PLC fees to efficiently and effectively discharge your annual company accounting and tax obligations. Following receipt of a set of draft accounting numbers from your company, Healy Consultants Group PLC will more accurately advise accounting and tax fees. For a dormant company, Healy Consultants Group PLC fees are only €950. Accounts must be prepared according to Luxembourg GAAP;

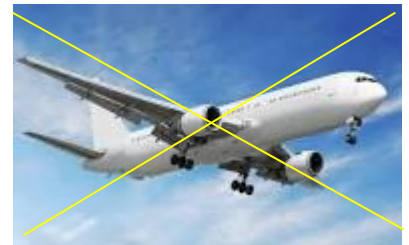

14. In accordance [Luxembourg Company Law 1915](#), the minimum share capital of a SARL Luxembourg company is €12,394.7, which must be deposited in a bank account prior to incorporation. To optimize engagement efficiency and minimize delays, Healy Consultants Group PLC is happy to deposit these funds on behalf of our clients.;
15. If our Client and Healy Consultants Group PLC properly plan this engagement, our Clients' will ***not*** have to travel during this engagement. Healy Consultants Group PLC will efficiently and effectively and aggressively complete company registration and corporate bank account opening in a timely manner without our Client presence. Instead, our Client will need to **i)** sign and get documents legalized in the embassy in their country of origin and **ii)** courier the originals to Healy Consultants Group PLC office;

The Government enjoys ultimate power of approval of visa applications. Consequently, guaranteed success is outside of Healy Consultants Group PLC' control. What is inside our control is the preparation and submission of a high quality immigration visa application that maximizes the likelihood of visa approval;
17. If our Client requires nominee [services \(click link\)](#), Healy Consultants Group PLC will be pleased to assist. Our annual fee for corporate nominee director or shareholder amounts to €2,800. Our annual fee for a non-resident individual nominee director or individual shareholder amounts to €4,600. Our annual fee for a Luxembourg resident nominee director or shareholder amounts to €11,850;
18. For an additional fee of €8,290 and to secure completion of the engagement in a timely manner, [Mr. Aidan Healy](#) will act as nominee shareholder, director and bank signatory for 3 months. With this nominee strategy, Healy Consultants Group PLC expects to complete company registration and corporate bank account opening without **i)** an immediate need for our Client's legalized documents and **ii)** without our Client's employee travel. That said, there is a 15% probability Healy Consultants Group PLC will need to revert to our Client during the engagement for corporate documents or the bank may request the bank signatory to travel;
19. If your Firm requires an office space in Luxembourg, Healy Consultants Group PLC will be pleased to assist. Our one-time fee for this service amounts to €950. Healy Consultants Group PLC will assist our Client secure license approval; there may be additional engagement fees. However, the Government enjoys ultimate power of approval of company registrations and business licenses;
21. During the engagement, shareholders and directors' documents may need to be translated into the local language; before the Government and Bank approves company registration and corporate bank account opening respectively. Consequently, our Client should budget for possible additional translation and embassy attestation fees. Either our Client or Healy Consultants Group PLC can complete this administrative task;
