Notes to invoice above:

1. Healy Consultants Group PLC's fees to legally register our Client Ukraine LLC with our temporary professional, passive nominee <u>shareholders and directors</u> and bank signatory. Within <u>4 weeks</u>, my team and I will email you i) a company registration number ii) a corporate bank account number iii) a city center business address iv) a tax number and iv) a proforma Ukraine sales invoice template complying with Ukraine company law;

Within <u>6 weeks</u>, our Client can legally conduct business in Ukraine; including <u>i</u>) issue sales invoices to local customers <u>ii</u>) sign customer and supplier contracts <u>iii</u>) sign a lease agreement for long term physical office and warehouse premises <u>iv</u>) and hire local and expatriate employees including secure employment visa approval;

All engagement fees are agreed and paid up front and agree to the fees published on our country web pages (click link). Consequently, there are no hidden fees nor surprises nor ambushes throughout the engagement. All engagement deadlines are agreed up front in the form of a detailed project plan, mapping out deliverables by week throughout the engagement term;



Every week during the engagement, Healy Consultants Group PLC emails our Client a detailed email engagement <u>status update</u>. our Client is immediately informed of engagement problems and solutions. In accordance with <u>Ukraine Law on Limited Liability Companies</u>, a company shall as from the date of its incorporation have a registered office in Ukraine, to which official government communications and notices may be addressed. To comply with this requirement, Healy Consultants' Ukraine office will be the registered office address for your company. Thereafter, this address will be used to receive government correspondence including i) tax letters ii) notice of the legal annual return; and iii) all government communications. Most of our Clients wish to place <u>Healy Consultants' office address</u> on invoices, contracts, websites and business cards;
- 3. In accordance with <u>Ukraine Law on Limited Liability Companies</u>, each entity must register for corporate tax and VAT with the <u>State Tax Authority</u>. usually, it takes 2 weeks to secure tax numbers;

4. Healy Consultants Group PLC will be pleased to open a Ukraine corporate <u>bank account</u>, without your travel. It is a time-consuming task; Healy Consultants will shelter our Client from the administrative hurdles. As you can appreciate, it is a challenging task to secure corporate bank account approval through a newly formed company;

At the beginning of the engagement, Healy Consultants Group PLC will secure corporate bank account approval using our professional, passive nominee shareholder, director and bank signatory. We will prepare a quality business plan for the bank; to optimize the probability of corporate bank account approval. Following completion of Ukraine business set up, our Client will appoint their preferred shareholders and directors and bank signatory;

Depending on our Client business and nationality, there is a 50% probability the banks will request beneficial owners and future bank signatories to travel to Ukraine for a one hour bank interview. Healy Consultants Group PLC will try its best to negotiate with the bank for a travel exemption. If our Client must travel to Ukraine for bank account signatory change, Healy Consultants will refund our Client US\$1,250;







The banks enjoy ultimate power of approval of corporate bank account applications. Consequently, guaranteed success is outside of Healy Consultants Group PLC's control. What is inside our control is the preparation and submission of a high-quality bank application; maximizing the likelihood of approval. To date, we enjoy a 100% approval record because of <u>our banking relationships</u> and determination;

Global banks continue to tighten corporate bank account opening procedures, their internal compliance departments completing more thorough due diligence of Clients. Consequently, our Clients should expect the bank account approval period to take up to 4 weeks. See also note below for further details on timelines for bank signatory changes. Furthermore, global banks now might also require evidence of proof of business, including sales contracts or lease agreement;

- 5. This fee is an estimate of government costs payable during your Firm's engagement. All Government fee payments will be supported by original receipts and invoices. Examples of Government costs include Examples of Government costs include i) paying the registration fee at the Unified State Register of Enterprises and Organizations; ii) obtaining a statement of receipt from the Pension Fund of Ukraine iii) preparing the company stamp iv) registering at the District Tax Inspectorate. Following engagement completion, Healy Consultants Group PLC will refund our Client any excess of funds received over actual Government costs paid;
- 6. In accordance with the with Ukraine company director must have a Ukraine work permit. It takes at least 4 months to secure work permit approval. To efficiently and effectively secure company registration in a timely manner, most of our Clients request Healy Consultants Group PLC to appoint a temporary nominee resident director. If required, Healy Consultants Group PLC resident director service fee amounts to US\$4,600 per annum;

Furthermore, every bank signatory of a Ukraine corporate bank account must hold a Ukraine work visa. Consequently, we recommend our Clients' to appoint a director who will also be the bank signatory. Thereafter, Healy Consultants Group PLC will help our Client secure a Ukraine work visa for our Client;

If required, Healy Consultants Group PLC will be pleased to provide our Client with a full package of passive professional nominee services and bank signatory for four months until the corporate structure is successfully changed. Our fee is US\$9,950 for this service;

7. Following business set up completion, Healy Consultants Group PLC assists our Client appoint their preferred shareholders and directors and bank signatory. Depending on our Client business and the efficiency of the Government and bank Departments, this process can take up to 4 months. This is the hardest part of the engagement;

This fee covers Healy Consultants professional fee to assist our Client secure the amended certificate of incorporation. Before the Ukraine bank approves our Clients' preferred bank signatory, the bank in-house Legal and Compliance Department will request additional Know Your Customer documents. Change of

corporate structure and of bank signatory is a time-consuming task, but Healy Consultants Group PLC will shelter our Client from this administrative burden;


- 10. All fees quoted in this invoice correspond to fees quoted on Healy Consultant Group PLC's <u>business</u> website. Please review this invoice carefully to identify errors. During the rush of a business day, it is possible Healy Consultants inadvertently made fee calculation errors, typing errors or omitted services or omitted historic fee payments from Clients. In the unfortunate event, you identify invoice errors, please revert to me directly re the same. I apologize in advance if I or my staff made invoice errors;
- 11. Assuming our Clients re-engage Healy Consultants Group PLC in year 2, this fee is an estimate of the fees payable next year, 12 months after the date of company registration;
- 12. Some of our Clients engage Healy Consultants Group PLC to <u>recruit</u> local employees. We have a lot of experience in this area and we are quite skilled at securing quality candidates for our Clients;
- 13. The fees quoted in this sales invoice today, are a prediction of the fees required to efficiently and timely complete this engagement. If during the engagement Healy Consultants Group PLC realizes that the project is more complex than anticipated, requiring a large additional investment of time, my Firm will revert to request additional fees. If Healy Consultants completes the engagement faster than expected and more easily than expected, Healy Consultants Group PLC is happy to refund some fees to our Client;
- 14. In accordance with <u>Ukraine Corporate Law</u>, there is no minimum issued share capital required. However, Healy Consultants recommends our Clients to allocate at least US\$5,000 (UAH120,000) to ensure a smooth completion of Ukraine company setup. The paid-up share capital may vary depending on our Client business. To optimize engagement efficiency and minimize delays, Healy Consultants Group PLC is happy to deposit these funds on behalf of our Clients;
- 15. Monthly and quarterly Government tax obligations include i) payroll and personal income tax reporting on behalf of employees (if any) ii) monthly VAT returns and payments iii) quarterly report over the use of the invoice book and iv) quarterly corporate tax provisional payments. If you need our help, Healy Consultants Group PLC can complete monthly Government reporting for a monthly fee of US\$660. Healy Consultants monthly support will include i) receive in dropbox the monthly invoices from our Client ii) label monthly bank statement transactions iii) preparation and submission of VAT returns and iv) monitor monthly profit levels to minimize annual tax v) submission of monthly employee payroll reporting;

The Government enjoys ultimate power of approval of visa applications. Consequently, guaranteed success is outside of Healy Consultants Group PLC's control. What is inside our control is the preparation and submission of a high-quality immigration visa application that maximizes the likelihood of visa approval;
- 18. Depending on our Client business and nationality, the Government may require a special regulatory license to carry on your business in the country. Healy Consultants Group PLC will assist our Client secure license approval. There may be additional fees for this service. However, the Government enjoys ultimate power of approval of company corporate structure changes and business licenses;
- 19. During the engagement, shareholders and directors documents may need to be translated into Ukrainian, before the Government and Bank approves corporate structure changes and bank account signatory change respectively. Consequently, our Client should budget for possible additional translation and embassy attestation fees. Either our Client or Healy Consultants can complete this administrative task;
 - As always, Healy Consultants Group PLC will negotiate with all third parties to eliminate or reduce additional engagement costs. For transparency purposes, all third-party fee payments will be supported by original receipts and invoices. Examples of possible third party payments include i) embassy fees ii) notary public costs iii) official translator fees;
