- 7. For an active trading company, these <u>accounting and tax</u> fees are an estimate of Healy Consultants Group PLC fees to efficiently and effectively discharge your annual company accounting and tax obligations. 

To optimize engagement efficiency and minimize delays, Healy Consultants Group PLC is happy to deposit these funds on behalf of our clients. Each share must have a par value of at least CHF100;
- 12. In accordance with <u>Article 718</u>, <u>paragraph 4 of the Swiss "Code des Obligations</u>", each Switzerland Auxiliary company must have at least one individual director ordinarily resident in Switzerland.
