 Healy Consultants' fees to efficiently and effectively project manage Client's DR Congo engagement within <u>5 months (click link)</u>, including <u>i</u>) choosing the optimum regulatory license for our Client's business activities, <u>ii</u>) reserving the simplified joint stock compay (JSC) name <u>iii</u>) liaising with lawyers and accountants and <u>iv</u>) submitting a quality simplified JSC incorproation application to the <u>Guichet Unique de la Création d'Entreprises</u>;

All <u>engagement fees</u> (click link) are agreed and paid up front and agree to the fees published on our country web pages. Consequently, there are no hidden fees or surprises or ambushes throughout the engagement. All engagement deadlines are agreed up front in the form of <u>a detailed project plan</u>, mapping out deliverables by week throughout the engagement term;



Every second day during the engagement, we email our Client a <u>detailed email engagement status</u> <u>update</u>. Our Client is immediately informed of engagement problems together with solutions. Thereafter, this address will be used to receive Government correspondence including a) annual and quarterly tax returns; b) bank statements and c) employee payroll tax and pension correspondence. Most of our Clients wish to place Healy Consultants <u>DR Congo office address</u> (click link) on invoices, contracts, websites and business cards;
- 3. This fee is an estimate of government costs payable during your Firm's engagement. All government fee payments will be supported by original receipts and invoices. Examples of government costs include i) registering the simplified JSC bylaws; ii) obtaining the RCCM number; iii) registering the simplified JSC for tax with the <u>Direction Générale des Impots</u>. Following engagement completion, Healy Consultants will refund our Client any excess of funds received over actual Government costs paid;

All banks will be top tier banks in these countries with excellent internet banking services. Example of our global banking partners include HSBC, Standard Chartered Bank, Citibank, Barclays, Standard bank, ANZ bank, Ecobank, UBS, Credit Suisse;

The banks enjoys ultimate power of approval of corporate bank account applications. Consequently, guaranteed success is outside of Healy Consultants' control. What is inside our control is the preparation and submission of a high quality bank application that maximizes the likelihood of approval. To date, we enjoy a 100% approval record because of <u>our global banking relationships</u> and determination.

Global banks continue to tighten corporate bank account opening procedures, their internal compliance departments completing more thorough due diligence of Clients. Consequently, our Clients should expect the bank account approval period to take up to 4 weeks. Furthermore, global banks now require evidence of proof of business in the country where the corporate bank account will be, including sales contracts or lease agreement;

- 9. Assuming our Clients' re-engage Healy Consultants in year 2, this fee is an estimate of the fees payable next year, 12 months after the date of company registration;
- 10. The fees quoted in this invoice are a prediction of the fees required to efficiently and effectively complete this engagement in a timely manner. If during the engagement Healy Consultants realizes that the project is more complex than anticipated, requiring a large additional investment of time, my Firm will revert to request additional fees. If Healy Consultants completes the engagement faster than expected and more easily than expected, Healy Consultants is happy to refund some fees to our Client:
- 11. In accordance with <u>DR Congo Companies Act</u>, the issued share capital of US\$1 must be deposited to the simplified JSC bank account before incorporation. To optimize engagement efficiency and minimize delays, Healy Consultants is happy to deposit these funds on behalf of our Clients;
- 12. It is important our Clients are aware of their personal and corporate tax obligations in their country of residence and domicile and they will fulfill those obligations annually. Let us know if you need Healy Consultants help to clarify your local and international annual tax reporting obligations;
- 13. Healy Consultants will be pleased to provide our Client nominee services for their DR Congo simplified JSC. Our fee for offering nominee legal representative service is U\$\$9,000. Additionally, if our Client requires nominee shareholder and director services (click link), Healy Consultants will be pleased to assist. Our fee for professional, passive nominee corporate shareholder amounts to U\$\$2,100 per annum. Our fee to be both nominee director and shareholder amounts to U\$\$6,600 per annum. Being the sole shareholders and sole director of a Client's simplified JSC exposes Healy Consultants to reputation, litigation and financial risk;
