Notes to invoice above

 Healy Consultants fees to efficiently and effectively complete Andorra company registration within six weeks by i) choosing the optimum regulatory license for our Client's business activities ii) reserving a company name with Oficina de Marques del Principat d'Andorra (OMPA) iii) settling our accountant and lawyer fees and iv) preparing a high quality company incorporation application for Oficina de Marques del Principat d'Andorra (OMPA);

All <u>engagement fees</u> (click link) are agreed and paid up front and agree to the fees published on our country web pages. Consequently, there are no hidden fees, surprises or ambushes throughout the engagement. All engagement deadlines are agreed up front in the form of a <u>detailed project plan</u>, mapping out <u>deliverables</u> by week throughout the engagement term;



Every week during the engagement, Healy Consultants will email our Client a <u>detailed status</u> <u>update</u>. Our Client is immediately informed of engagement problems together with solutions. In accordance with Andorra Foreign Direct Investment Law 2012, an LLC shall as from the date of its incorporation have a legal registered office in Andorra, to which all official government communications and notices may be addressed. To comply with this statutory requirement, Healy Consultants' Andorra office will be the registered office address for your company. Thereafter, this address will be used to receive government correspondence including i) tax letters ii) notice of the legal annual return; and iii) all government communications. Most of our Clients wish to place Healy Consultants' office address on invoices, contracts, websites and business cards;
- 3. This fee is an estimate of government costs payable during your Firm's engagement. For transparency purposes, all government fee payments will be supported by original receipts and invoices. Examples of government costs include i) reserving company name with the Oficina de Marques del Principat d'Andorra (OMPA); ii) notarizing the memorandum and petition for incorporation and iii) limited liability company registration with the OMPA. Following engagement completion, Healy Consultants will refund our Client any excess of funds received over actual Government costs paid;

4. Healy Consultants will be pleased to open an Andorra corporate bank account without travel. It is a time consuming task, Healy Consultants will shelter our Client from the administrative challenges. As you can appreciate, it is a difficult task to obtain bank account approval through a newly formed company, when shareholders and directors and bank signatories reside overseas. Healy Consultants will prepare a business plan for the bank to optimize the probability of corporate bank account approval. Depending on our Client business and nationality, there is a 50% probability the banks will request a bank signatory to travel for a one hour bank interview. Healy Consultants will try its best to negotiate with the bank for a travel exemption. If our Client must travel to Andorra for corporate bank account opening, Healy Consultants will refund our Client €950;

If our Client is not comfortable with only an Andorra corporate bank account, Healy Consultants will be pleased to open an international corporate bank account (click link) outside of the country. Examples include New York, Germany, Liechtenstein, Austria, Bulgaria, South Africa, Australia, London, South America or Dubai. All banks will be top tier banks in these countries with excellent internet banking services. Example of our global banking partners include HSBC, Standard Chartered Bank, Citibank, Barclays, Standard bank, ANZ bank, VTB bank, UBS, Credit Suisse;

The banks enjoys ultimate power of approval of corporate bank account applications. Consequently, guaranteed success is outside of Healy Consultants' control. What is inside our control is the preparation and submission of a high quality bank application that maximizes the likelihood of approval. To date, we enjoy a 100% approval record because of <u>our global banking relationships</u> and determination.

Global banks continue to tighten corporate bank account opening procedures, their internal compliance departments completing more thorough due diligence of Clients. Consequently, our Clients should expect the bank account approval period to take at least 6 weeks. Furthermore, global banks now require evidence of proof of business in the country where the corporate bank account will be, including sales contracts or lease agreement;







 In accordance with <u>Andorra Foreign Direct Investment Law 2012</u>, each entity must register for corporate tax and VAT at the <u>Andorra Ministry of Finance</u>;

6. If required, Healy Consultants will be pleased to assist your Firm to secure employee <u>visa</u> approvals. Our fee is €4,950 for the first employee, €3,950 for the second employee, €2,950 per employee thereafter. Our employee visa fees includes preparation of a quality visa application and submitting to the correct Government immigration officers.

The Government enjoys ultimate power of approval of visa applications and will require our Client to demonstrate: i) a viable business plan in Andorra ii) intention to hire multiple local employees iii) evidence of expected local customers and suppliers iv) qualifications and degree for the position applied and v) funds and finance to develop the business and finance its expenses. Consequently, Healy Consultants recommends to inject a minimum of €200,000 paid up capital to the corporate bank account of the entity, before submitting a visa application. Guaranteed success is outside of Healy Consultants' control. What is inside our control is the preparation and submission of a high quality immigration visa application that maximizes the likelihood of visa approval;

- 7. Healy Consultants Group PLC project management fees relate to time and resources dedicated to:
 - a. thoroughly research and plan Andorra business setup and visa approval for our Client;
 - b. devising strategies to i) minimise the total engagement period ii) complete the engagement without our Client travelling for company and corporate bank account opening iii) avoid the need for a Andorra national shareholder and iv) avoid the need for a specific regulatory license;

- 10. Assuming our Clients re-engage Healy Consultants in year 2, this fee is an estimate of the fees payable next year, 12 months after the date of company registration;
- 11. The fees quoted in this invoice are a prediction of the fees required to efficiently and effectively complete this engagement in a timely manner. If during the engagement Healy Consultants realizes that the project is more complex than anticipated, requiring a large additional investment of time, my Firm will revert to request additional fees. If Healy Consultants completes the engagement faster and more easily than expected, Healy Consultants is happy to refund some fees to our Client;
- 12. Engage Healy Consultants to <u>project manage</u> business set up in every country on the planet. We are the best in the <u>world</u> at what we do, timely completing the A to Z of every country engagement;
- 13. In accordance with <u>Andorra Foreign Direct Investment Law 2012</u>, the issued share capital of €3,000 must be deposited to the company bank account before company formation. Higher capital amounts will be required before submission of a work permit application. To optimize engagement efficiency and minimize delays, Healy Consultants is happy to deposit these funds on behalf of our clients;
- 14. Depending on our Client's business and nationality, the Andorra Government may require a special regulatory license to carry on your business in the country. Healy Consultants will assist our Client secure license approval; there may be additional engagement fees. However, the Government enjoys ultimate power of approval of company registrations and business licenses;

- 15. If our Client requires nominee shareholder and director services (click link), Healy Consultants will be pleased to assist. Our fee for professional, passive nominee corporate non resident shareholder amounts to €3,100 per annum. Our fee to be both nominee non resident director and shareholder amounts to €6,600 per annum. Being the sole shareholders and sole director of a Client's company exposes Healy Consultants to reputation, litigation and financial risk;
- 16. Monthly, quarterly and mid-year Government tax obligations include monthly and quarterly payroll reporting, VAT and corporation tax return filing. If you need our help, Healy Consultants can complete monthly Government reporting for a monthly fee of €1,860. Healy Consultants monthly support will include i) receive in dropbox the monthly invoices from our client ii) label monthly bank statement transactions iii) preparation and submission of VAT returns and iv) submission of monthly employee payroll reporting;
- 17. Unfortunately, all shareholders and directors must be present up to 3 days for notarization of company application documents in Andorra. This requirement is mandatory and cannot be negated;
- 18. Some of our Clients request Healy Consultants to provide temporary shared <u>office space</u> for 6 months until their preferred business premises is found. If your Firm requires this service, our one-time fee is €950. Monthly rental thereafter is paid directly to the landlord, independently of Healy Consultants;
- 19. It is important our Clients are aware of their personal and corporate tax obligations in their country of residence and domicile. Let us know if you need Healy Consultants help to clarify your local and international annual tax reporting obligations;
- 20. During the engagement, shareholders and directors' documents may need to be translated into the local language; before the Government and Bank approves company registration and corporate bank account opening respectively. Consequently, our Client should budget for possible additional translation and embassy attestation fees. Either our Client or Healy Consultants can complete this administrative task:
