In accordance with section 85 of the <u>Brunei International Trust Order 2000</u>, the trustees shall keep in Brunei Darussalam at the office of the trust corporation a documentary record of i) terms of trust, ii) identity of trustee and enforcers and iii) settlement of the property, amongst others. To comply with this statutory requirement, Healy Consultants Brunei business office will be the registered office address for your Brunei trust. Thereafter, this address will be used to receive Government correspondence including i) tax letters and ii) all government communications.

3. Healy Consultants will be pleased to open a Brunei business bank account without travel. It is a time consuming task, Healy Consultants will shelter our Client from the administrative challenges. As you can appreciate, it is a difficult task to obtain bank account approval through a newly formed trust, when authorized personnel reside overseas. Healy Consultants will prepare a business plan for the bank to optimize the probability of corporate bank account approval. Depending on our Client business and nationality, there is a 20% probability the banks will request a bank signatory to travel for a one hour bank interview. Healy Consultants will try its best to negotiate with the bank for a travel exemption. If our Client must travel to Brunei for business bank account opening, Healy Consultants will refund our Client US\$950;

If our Client is not comfortable with a Brunei business account, Healy Consultants will be pleased to open an open <u>an international trust bank account</u> outside of Brunei. Global banks continue to tighten trust bank account opening procedures, their internal compliance departments completing more thorough due diligence of Clients. Consequently, our Clients should expect the bank account approval period to take up to 4 weeks. Furthermore, global banks now require evidence of proof of business in the country where the bank account will be, including sales contracts or lease agreement:

9. If our Client and Healy Consultants properly plan this engagement, our Clients' will <u>not</u> have to travel during this engagement. Instead, our Client will need to i) sign and get documents legalized in the Embassy in their country of origin and ii) courier the originals to Healy Consultants office;

Consequently, our Client should budget for possible additional translation and Embassy attestation fees. Either our Client or Healy Consultants can complete this administrative task;
 - As always, Healy Consultants will negotiate with all third parties to eliminate or reduce additional engagement costs. For transparency purposes, all third party fee payments will be supported by original receipts and invoices. Examples of possible third party payments include i) Embassy fees ii) notary public costs iii) official translator fees;
- 13. To assist our Clients to minimize foreign exchange costs, we offer the payment in SG\$, Euro, Pounds or US\$. Kindly let me know in which currency your Firm prefers to settle our fees and I will send an updated invoice, thank you;
