1. Healy Consultants fees to efficiently and effectively complete Bulgaria company registration within two weeks (click link). by i) choosing the optimum regulatory license for our Client's business activities; ii) reserving a company name with the Trade Register iii) settling our accountant and lawyer fees and iv) preparing a high quality company incorporation application with the Trade Register;

All <u>engagement fees</u> (click link) are agreed and paid up front and agree to the fees published on our country web pages. Consequently, there are no hidden fees, surprises or ambushes throughout the engagement. - 3. This fee is an estimate of Government costs payable during your Firm's engagement. All Government fee payments will be supported by original receipts and invoices. Examples of Government costs include i) company name application with the Irade Register of the BCCI; ii) preparation of company deeds and iii) paying the BCCI business registration fee;. - 12. The minimum share capital required for Bulgarian company set up is €1. A temporary bank account for the contribution of share capital must be opened prior company incorporation.
