### Notes to invoice above

1. Healy Consultants' fees to efficiently and effectively complete Belize FZ LLC free registration within 1 week by **i)** choosing the optimum regulatory license for our Client's business activities; **ii)** reserving a free zone company name with [Registry of Corporate Affairs](#); **iii)** settling our accountant and lawyer fees and; **iv)** preparing a high quality free zone company incorporation application for [Registry of Corporate Affairs](#); **v)** preparing a high quality business plan for the [Free Zone authorities](#);

All [engagement fees](#) (click link) are agreed and paid up front and agree to the fees published on our country web pages. Consequently, there are no hidden fees or surprises or ambushes throughout the engagement. All engagement deadlines are agreed up front in the form of [a detailed project plan](#), mapping out deliverables by week throughout the engagement term;



Every week during the engagement, we email our Client a [detailed email engagement status update](#). Our Client is immediately informed of engagement problems together with solutions. Your dedicated engagement manager is reachable by phone, skype, live chat and email and will communicate in your preferred language;

2. In accordance with the [Belize Companies Act](#), each Belize free zone company must appoint a free zone company secretary, who may be a natural person or a body corporate, but the free zone company secretary must be resident in Belize. Healy Consultants will act as your Belize Free zone company Secretary, for which our annual responsibilities include **i)** preparation and filing of the annual return; **ii)** securely maintaining free zone company records; **iii)** liaising with the Belize Government on behalf of our Client; **iv)** legal filing of changes of free zone company structure and; **v)** ensuring free zone company record compliance with local free zone company law;
3. The initial requirement by the Government of Belize when incorporating a free zone company in the free zone is to reserve operational premises. If your firm requires this service from Healy Consultants Group PLC Group PLC, our one-time fee amounts to US\$1,950. The monthly rent thereafter will be paid independently and directly to the Authority by our Client. An estimate of such rental for a space is approximately US\$20 per square meter per year, and the rental terms are usually six months' rental as security deposit;
4. This fee is an estimate of Government costs to complete your Firm's engagement. For transparency purposes, all government fee payments will be supported by original receipts and invoices. Examples of Government costs include **i)** reserving the free zone company name with the [Registry of Corporate Affairs](#); **ii)** preparation of free zone company memorandum and articles of association; **iii)** applying for trade registration at the [City Council](#); **iv)** preparation of the free zone company seal and; **v)** applying for the Export Processing Zone Program . Following engagement completion, Healy Consultants will refund our Client any excess of funds received over actual Government costs paid;

5. Healy Consultants will be pleased to open a Belize corporate bank account without our Client's travel. It is a time consuming task, and Healy Consultants will shelter our Client from the associated administrative challenges. As you can appreciate, it is a difficult task to obtain bank account approval through a newly formed free zone company when shareholders, directors and bank signatories reside overseas. Depending on our Client's business and nationality, there is a 20% probability the banks will request a bank signatory to travel for a one-hour bank interview. Healy Consultants will try its best to negotiate with the bank for a travel exemption. If our Client must travel to Belize for corporate bank account opening, Healy Consultants will refund our Client US\$950;

If our Client is not comfortable with only a Belize corporate bank account, Healy Consultants will be pleased to open [an international corporate bank account](#) (click link) outside of Belize. Examples include New York, Germany, Liechtenstein, Austria, Bulgaria, South Africa, Australia, London, South America or Dubai. All banks will be top tier banks in these countries with excellent internet banking services. Example of our global banking partners include HSBC, Standard Chartered Bank, Citibank, Barclays, Standard bank, ANZ bank, VTB bank, UBS, Credit Suisse;

Healy Consultants will prepare a business plan for the bank to optimize the probability of corporate bank account approval. However, the banks enjoy the ultimate power of approval of corporate bank account applications. Consequently, guaranteed success is outside of Healy Consultants' control. What is inside our control is the preparation and submission of a high-quality bank application that maximizes the likelihood of approval;

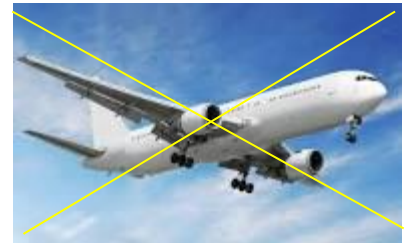

Furthermore, global banks now require evidence of proof of business in the country where the bank account will be, including sales contracts or lease agreement;

6. For an active trading free zone company, these [accounting and tax](#) fees are an estimate of Healy Consultants fees to efficiently discharge your annual free zone company accounting and tax obligations. Following receipt of a set of draft accounting numbers from your free zone company, Healy Consultants will more accurately advise accounting and tax fees. For a dormant free zone company, Healy Consultants fees are only US\$950;

7. All fees quoted in this invoice correspond to fees quoted [on Healy Consultants' website](#). Please review this invoice carefully to identify errors. During the rush of the business day, it is possible that Healy Consultants inadvertently made fee calculation errors, typing errors or omitted services or omitted historic fee payments from Clients. In the unfortunate event you identify invoice errors, please revert to me directly re the same. I apologize in advance if I or my staff made invoice errors;
8. Assuming our Clients re-engage Healy Consultants in year 2, this fee is an estimate of the fees payable next year, 12 months after the date of free zone company registration;
9. The fees quoted in this invoice are a prediction of the fees required to efficiently and effectively complete this engagement in a timely manner. If during the engagement Healy Consultants realizes that the project is more complex than anticipated, requiring a large additional investment of time, my Firm will revert to request additional fees. If Healy Consultants completes the engagement faster and more easily than expected, Healy Consultants is happy to refund some fees to our Client;
10. Engage Healy Consultants to [project manage](#) business set up in every country on the planet. We are the best in the [world](#) at what we do, timely completing [the A to Z](#) of every country engagement;
11. If our Client requires nominee shareholder and director [services \(click link\)](#), Healy Consultants will be pleased to assist. Our fee for professional, passive nominee corporate shareholder amounts to US\$2,100 per annum. Our fee to be both nominee director and shareholder amounts to US\$6,600 per annum. Being the sole shareholders and sole director of a Client's free zone company exposes Healy Consultants to reputation, litigation and financial risk;
12. If our Client and Healy Consultants properly plan this engagement, our Clients will **not** have to travel during this engagement. Healy Consultants will efficiently complete free zone company registration and corporate bank account opening in a timely manner without our Client's presence. Instead, our Client will need to **i)** sign and get documents legalized in the embassy in their country of origin and; **ii)** courier the originals to Healy Consultants office;
13. Depending on our Client's business and nationality, the Belize Government may require a special regulatory license to carry on your business in the country. Healy Consultants will assist our Client secure license approval. However, the Government enjoys ultimate power of approval of free zone company registrations and business licenses;
14. It is important our Clients are aware of their personal and corporate tax obligations in their country of residence and domicile; and they will fulfill those obligations annually. Let us know if you need Healy Consultants help to clarify your local and international annual tax reporting obligations;

- 15.** Some of our Clients request Healy Consultants to provide temporary shared [office space](#) for 6 months until their preferred business premises is found. If your Firm requires this service, our one-time fee is US\$950. Monthly rental thereafter is paid directly to the landlord, independently of Healy Consultants;
- 16.** Monthly, quarterly and mid-year Government tax obligations include monthly and quarterly payroll reporting, VAT and corporation tax return filing. If you need our help, Healy Consultants can complete monthly Government reporting for a monthly fee of US\$860. Healy Consultants monthly support will include **i)** receive in Dropbox the monthly invoices from our Client; **ii)** label monthly bank statement transactions; **iii)** preparation and submission of VAT returns and; **iv)** submission of monthly employee payroll reporting;
- 17.** If required, Healy Consultants will be pleased to assist your firm to secure employee visa approvals. Our fee is US\$4,950 for the first employee, US\$36,950 for the second employee, US\$2,950 per employee thereafter. Our employee visa fees includes preparation of a quality visa application and submitting to the correct Government immigration officers. The Government enjoys ultimate power of approval of visa applications. Consequently, guaranteed success is outside of Healy Consultants' control. What is inside our control is the preparation and submission of a high quality immigration visa application that maximizes the likelihood of visa approval;
- 18.** During the engagement, shareholders and directors documents may need to be translated into the local language before the Government and Bank approves free zone company registration and corporate bank account opening respectively. Consequently, our Client should budget for possible additional translation and embassy atestation fees. Either our Client or Healy Consultants can complete this administrative task;
- As always, Healy Consultants will negotiate with all third parties to eliminate or reduce additional engagement costs. For transparency purposes, all third-party fee payments will be supported by original receipts and invoices. Examples of possible third-party payments include **i)** embassy fees; **ii)** notary public costs; **iii)** official translator fees;
- 19.** Some of our Clients require an [immediate country solution](#). With this strategy, within a day Healy Consultants can supply our Client **i)** an existing dormant Belize free zone company number and; **ii)** an already approved international corporate bank account number and; **iii)** a business address. Turnkey solutions are attractive to those entrepreneurs who wish to immediately close a country deal, sign a contract or invoice a customer;
- 20.** As stipulated on our [business website](#) and in section 3 of our engagement letter, Healy Consultants will only commence the engagement following **i)** settlement of our fees and; **ii)** completion and signing of our legal engagement letter;
- 21.** Healy Consultants will only incorporate your free zone company after 75% of [due diligence documentation](#) is received by email. Healy Consultants will only open a corporate bank account after 100% of the Client's original due diligence documentation is received by courier;
