- 3. In accordance with the Mauritius Foundation Act of 2012, each Mauritius foundation must have at least one individual council member ordinarily resident in Mauritius. If required, our local agent will be pleased to provide your firm with a professional nominee member in Mauritius. Our annual fee amounts to US\$5,450 per professional qualified Mauritius resident council member. Up to three other founders can be appointed and they can be non-Mauritius residents.
- 4. Healy Consultants Group PLC will be pleased to open an international corporate bank account without our Client needing to travel.
