Healy Consultants Group PLC will act as your Gibraltar fintech software developer company secretary, for which our annual responsibilities include i) preparing and filing the legal annual return; ii) securely maintaining fintech software developer company records; iii) liaising with the Gibraltar government on our Client's behalf; iv) legal filing of changes of fintech software developer company structure; and v) reminding our Client of statutory deadlines;

In accordance with <u>s. 178 of the Gibraltar Companies Act 2014-09</u>, a Gibraltar Fintech software developer company shall as from the date of its incorporation have a legal registered office in Gibraltar, to which all official Government communications and notices may be addressed. To comply with this statutory requirement, Healy Consultants Group PLC Gibraltar office will be the registered office address for your fintech software developer company. Thereafter, this address will be used to receive government correspondence including i) tax letters; ii) notice of the legal annual return; and iii) all government communications. Most of our Clients wish to place <u>Healy Consultants Group PLC's office address</u> on invoices, contracts, websites and business cards;

- 3. This fee is an estimate of government costs payable during your Firm's engagement. For transparency purposes, all government fee payments will be supported by original receipts and invoices. Examples of government costs include i) registration fees at the <u>Gibraltar Companies House</u>; and ii) issuance of the fintech software developer company seal. Following engagement completion, Healy Consultants Group PLC will refund our Client any excess of funds received over actual Government costs paid;

- 6. For an active trading fintech software developer company, these <u>accounting and tax</u> fees are an estimate of Healy Consultants Group PLC fees to efficiently and effectively discharge your annual fintech software developer company accounting and tax obligations. Following receipt of a set of draft accounting numbers from your fintech software developer company, Healy Consultants Group PLC will more accurately advise accounting and tax fees. For a dormant fintech software developer company, Healy Consultants Group PLC will more accurately advise accounting and tax fees. For a dormant fintech software developer company, Healy Consultants Group PLC fees are only £950;

- 11. If our Client and Healy Consultants Group PLC properly plan this engagement, our Clients will <u>not</u> have to travel during this engagement. Healy Consultants Group PLC will efficiently complete company registration and corporate bank account opening in a timely manner without our Client's presence. Instead, our Client will need to i) sign and get documents legalized in the embassy in their country of origin; and ii) courier the originals to Healy Consultants Group PLC's office;
