## Notes to invoice above

1. Healy Consultants Group PLC fees to efficiently and effectively complete Wyoming C-corporation registration within [3 weeks](#) (click link) from receipt of certified due diligence and signed incorporation forms by **i)** agreeing the optimum corporate structure for our Client's business activities; **ii)** securing regulatory license exemption **iii)** settling our accountant and lawyer fees **iv)** assisting our Client to legally minimize international tax and **v)** reserving the C-Corp name and preparing a quality C-Corp incorporation application for submission to the [Wyoming Secretary of State](#);

All [engagement fees](#) (click link) are agreed and paid up front and agree to the fees published on our country web pages. Consequently, there are no hidden fees, surprises or ambushes throughout the engagement. All engagement deadlines are agreed up front in the form of a [detailed project plan](#), mapping out [deliverables](#) by week throughout the engagement term;

2. In accordance with [Wyoming regulations](#), each Wyoming C-Corp must appoint a registered agent, who may be a natural person or a body corporate, but the agent must be resident in the country. Healy Consultants Group PLC will supply the Wyoming agent of your C-Corp, and our annual responsibilities include **i)** preparation and filing of the annual return **ii)** securely maintaining company records **iii)** liaising with the Wyoming Government on behalf of our Client **iv)** legal filing of changes of company structure and **v)** reminding our Client of statutory deadlines;

In accordance with [Wyoming Business Corporation Act](#), a Wyoming C-Corp shall as from the date of its incorporation have a legal registered office in Wyoming, to which all official government communications and notices may be addressed. To comply with this statutory requirement, Healy Consultants Group PLC will supply a Wyoming business office as the registered office address of your Wyoming Company. Thereafter, this address will be used to receive Government correspondence including **i)** annual and quarterly tax returns; **ii)** bank statements; **iii)** employee payroll tax and pension correspondence. Most of our Clients wish to place their [Wyoming office address \(click link\)](#) on invoices, contracts, websites and business cards. If our Client wants to use this address for commercial purposes (eg. receiving commercial correspondence at the address), this will attract [additional virtual office fees](#);

3. This fee is an estimate of government costs payable during your firm's engagement. All government fee payments will be supported by original receipts and invoices. Examples of government costs include **i)** reserving the company name and **ii)** apply for a Certificate of Good Standing. Following engagement completion, Healy Consultants Group PLC will refund our Client any excess of funds received over actual Government costs paid;
4. Without bank signatory travel, Healy Consultants Group PLC will secure a multi-currency corporate bank account numbers for our Client's US corporation. It will take on average [two months](#) to secure corporate bank account numbers from the moment a complete quality corporate bank account opening application is submitted to the banks. This is the most challenging part of the engagement. Consequently, we apply our [guaranteed bank account approval or your Money Back](#) policy. To

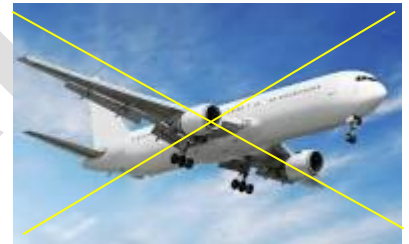

In accordance with [Internal Revenue Service \(IRS\)](#) guidelines, each entity which wishes to hire employees in the US must register for tax by applying for an [Employee Identification Number \(EIN\)](#). Tax registration (EIN issuance) can take up to 6 weeks from C-Corp registration. Should our Client register branch offices in other states and employ staff in those states, they will be required to register for state tax in each state they operate a branch within. Our fee to assist with state tax registration is US\$650 per state.
6. For an active trading C-Corp, these [accounting and tax](#) fees are an estimate of Healy Consultants fees to efficiently and effectively discharge your annual company accounting and tax obligations. Following receipt of a set of draft accounting numbers from your company, Healy Consultants will more accurately advise accounting and tax fees. For a dormant company, Healy Consultants Group PLC fees are only US\$950;
7. In accordance with [Singapore regulations](#), provision of company formation and project-management services to Singapore residents are subject to a 7% GST payable to the Singapore Government;
8. All fees quoted in this invoice correspond to fees quoted [on Healy Consultants Group PLC's website](#). Please review this invoice carefully to identify errors. During the rush of the business day, it is possible that Healy Consultants inadvertently made fee calculation errors, typing errors or omitted services or omitted historic fee payments from Clients. In the unfortunate event you identify invoice errors, please revert to me directly re the same. I apologize in advance if I or my staff made invoice errors;
9. Assuming our Clients re-engage Healy Consultants Group PLC in year 2, this fee is an estimate of the fees payable next year, 12 months after the date of company registration;
10. The fees quoted in this invoice are a prediction of the fees required to efficiently and effectively complete this engagement in a timely manner. 13. In accordance with [Wyoming Business Corporation Act](#), there is no minimum share capital amount mandated for Wyoming company incorporation;
14. If our Client requires nominee shareholder and director [services \(click link\)](#), Healy Consultants Group PLC will be pleased to assist. Our fee for professional, passive nominee corporate shareholder amounts to US\$2,100 per annum. Our fee to be both nominee director and shareholder amounts to US\$8,600 per annum. Being the sole shareholders and sole director of a Client's company exposes Healy Consultants to reputation, litigation and financial risk;
15. If our Client and Healy Consultants Group PLC properly plan this engagement, our Clients' will **not** have to travel during this engagement. Our Firm will efficiently and effectively complete company registration and corporate bank account opening in a timely manner without our Client presence. Instead, our Client will need to **i)** sign and get documents legalized in the embassy in their country of origin and **ii)** courier the originals to Healy Consultants office;
16. Depending on our Client's business and nationality, the US Government may require a special regulatory license to carry on your business in the country. Healy Consultants will assist our Client secure license approval; there may be additional engagement fees. However, the Government enjoys ultimate power of approval of company registrations and business licenses;
17. If required, Healy Consultants will be pleased to assist your firm to secure [employee visa](#) approvals. Our fee is US\$10,950 for the first employee, US\$9,950 for the second employee, US\$8,950 per employee thereafter. Our employee visa fees includes preparation of a quality visa application and submitting to the correct Government immigration officers. The Government enjoys ultimate power of approval of visa applications. Consequently, guaranteed success is outside of Healy Consultants' control. What is inside our control is the preparation and submission of a high quality immigration visa application that maximizes the likelihood of visa approval;
18. Some of our Clients request Healy Consultants to provide temporary shared [office space](#) for 6 months until their preferred business premises is found. If your Firm requires this service, our one-time fee is US\$950. Monthly rental thereafter is paid directly to the landlord, independently of Healy Consultants Group PLC;
