Because of higher rental costs, our Firm had to increase our fees in 2022. We hope this increase does not damage our business relationship with your Firm.
- 3. For the coming 12 months for your active Korean entity, these are Healy Consultants Group's fees to timely accurately complete VAT return <u>filing</u>. Our Client needs to supply our in-house Accounting and Tax Department with invoices and bank statements. In 2022, our VAT filing fees increased because of increased Korean lawyers and accountants' fees. We hope this does not damage our business relationship with your Firm.
- 4. While preparing this renewal invoice, our Firm assumed your Korean entity was active during the past accounting period 01-07-21 and 30-06-22. Consequently, these accounting and tax filing fees are an estimate of our fees to timely accurately and completely discharge your 2021 Korean statutory filing obligations.
