- According to the Qatari [Foreign Investment Law No. 13 of 2000](#), a Qatari national is required to hold at least 51% of the equity of a Qatar LLC, unless the entity is in a free zone. As always, Healy Consultants is happy to continue to act as the professional, passive nominee resident shareholder of JLL Qatar LLC. To ensure your assets are fully protected, Healy Consultants nominee shareholder will neither be a bank signatory nor play an active role in JLL local business activities; and
